Dear Mr. Donofrio:

I write with enthusiasm in response to my nomination by Dr. Roger Martin, retired President of Moravian College and Randolph-Macon College, to apply for the position of President, Southern Connecticut State University. On June 30, 2015, after seven satisfying and productive years, I stepped down from the presidency of Elmhurst College in Illinois to return to Massachusetts for a year-long appointment as a Visiting Scholar at Harvard Law School.

As I look to the future, I am interested in assuming a presidential role at a dynamic university where my executive skills can be used on behalf of a larger, more complex entity. After learning more about Southern Connecticut State University, the success you have achieved, and your aspirations for the future, I would very much like that entity to be Southern.

For the past 20 years, I have gained expertise in academic administration by assuming progressively more responsible, senior and executive-level roles. I have demonstrated leadership in a variety of institutions: an elite private professional school; a flagship, land-grant public research university facing financial challenges; and a medium-sized, tuition-driven liberal arts college. Here are a few lessons I learned along the way: to be fiscally prudent but also nimble and innovative; to assess and take reasonable financial and reputational risks that can build an institution and make it stand out among its peers; to compete aggressively with other schools, but also to partner and collaborate in possibly unforeseen ways; to plan strategically for the future, but also to watch for unexpected opportunities that may require deviation; and, to embrace technology, but only after carefully studying institutional needs and resources.

It may not be surprising, then, that my greatest strengths and achievements match the qualifications specified in Southern's presidential position description. I will not repeat information described with specificity in my curriculum vitae, but I will offer you this summary (below) of my relevant professional accomplishments as President of Elmhurst College.

- Launched market-driven graduate programs, leveraged online technology, and formed strategic partnerships through the School for Professional Studies, the College's first school, which I started in 2012.
- Demonstrated responsible fiscal stewardship over an annual operating budget of \$65M and endowment of \$100M during the Great Recession and its aftermath.

- During a period when national philanthropic giving was at an all-time low, fundraised over \$24M including \$11M from the President's prospect portfolio, and jump-started alumni engagement, regionally and across the country.
- Brought new intensity and focus to integrating local, state and national government leaders, corporate and nonprofit CEOs, into the College's mission, through one-on-one meetings and creative, well-planned campus events.
- Dramatically raised Elmhurst College's academic profile and reputation, breaking in US News & World Report's Top 10 Midwestern comprehensive universities, and winning accolades for civic engagement and service. As a proven reputation-builder, I would "tell the story" of Southern Connecticut State University as enthusiastically and effectively as I told the story of Elmhurst College.
- Transformed the campus into a multicultural environment reflecting diverse student backgrounds, abilities, and orientations.

In addition, over the past 30 years, I have:

- Initiated or collaborated on seven, successful strategic planning processes at higher education institutions.
- As Senior Vice Provost for the University of New Hampshire, Durham, gained hands-on experience with the University System Office and staff, and built strong relations with the Chancellor and leaders of UNH's three other campuses.
- Pursued my own program of undergraduate and graduate teaching, scholarly research, publication, and service.

Southern rightly expects its next President to be a great colleague, someone who enjoys working with people from all walks of life and institutional locations, and with whom others enjoy working, too. I believe I have gained a reputation as a constructive and collaborative colleague. Here are a few, admittedly eclectic, examples:

- Engaged UNH's unionized faculty and its leadership with transparency, and respected the norms of shared governance with Faculty Senate leadership. Advised the UNH Provost during lengthy contract negotiations, impasse, and work-to-rule situations, and developed corresponding communications strategies.
- Through weekly 1-1 meetings, frequent small group discussions, support of administrator professional development, and positive interactions with office staff, motivated eight UNH faculty program directors to collaborate, minimize turf-conflicts, work efficiently, and above all, *to put students first* in designing and executing programs.
- Co-designed and taught an Elmhurst College Honors Capstone Seminar on Foucault and Ethics with a tenured Philosophy colleague, and regularly guest-lectured on Native American topics in courses around the College.
- Initiated Staff Council at Elmhurst College, to improve communications among staff and give exempt and non-exempt employees a representative voice on budget and policy decisions.

- Used my skills as an attorney to mediate conflict and derive positive outcomes for all, whenever possible. Resolved interpersonal problems quickly, clearly, fairly, and discreetly. Maintained a sense of humor and cool head under pressure.
- Enthusiastically attended and contributed to innumerable student events in the arts, music, athletics, Greek system, and affinity groups. Started twice-monthly open office hours for students, inviting them to come in and speak with their President.

I look forward to learning more about the Board's expectations for the next President of Southern Connecticut State University and discussing how together we can work to build on the progress and momentum enjoyed under President Papazian.
