WHEREAS, Ms. Hoar began her career in education as an elementary school teacher in 1942 until her retirement as teacher and speech therapist in 1977, and

WHEREAS, Ms. Hoar was co-owner of Promotions, Inc. of Portland, Connecticut from 1949 through 1956, and

WHEREAS, Ms. Hoar graduated from Willimantic State Teachers' College and furthered her education at Southern Connecticut State University in graduate studies and certification as a speech therapist, and

WHEREAS, Ms. Hoar was a member of the Eastern Connecticut State University Alumni Association Board from 1955 through 1980, serving as President from 1966 through 1969 and 1973 through 1975 respectively, and

WHEREAS, Ms. Hoar has been a member of the ECSU Foundation, Inc. beginning in 1975 to the present while serving as President from 1981 through 1983, and

WHEREAS, She received the ECSU Presidential medal for Service to the University at the Centennial Ceremony in September of 1989, and

WHEREAS, She served on the Board of Trustees for the Connecticut State University System for 20 years from 1975 to 1995 including service as member and chair of the Finance Committee, member of the Executive and Personnel Committees, and member of the standing Advisory Committee to the Board of Governors for Higher Education, and




WHEREAS, Ms. Hoar was named Middlesex County Distinguished Citizen of the year in 1996, and

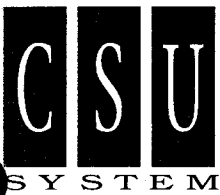



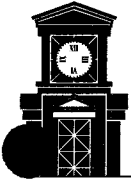
No further action by the Board is required and copies of this letter will be filed with the original resolutions for future reference.
