RESOLUTION

concerning

CONTINUATION OF THE CENTER FOR THE ENVIRONMENT

AT

SOUTHERN CONNECTICUT STATE UNIVERSITY

November 8, 2001

- WHEREAS, The Center for the Environment was established at Southern Connecticut State University by Board Resolution 89-8 and reauthorized by Board Resolution 97-29 with a sunset date of December 31, 2001, and
- WHEREAS, The President of Southern Connecticut State University has evaluated the work of the Center for the Environment and has recommended its continuation, therefore, be it
- RESOLVED, That the Board of Trustees for the Connecticut State University System authorizes the continuation of the Center for the Environment at Southern Connecticut State University and requires that the President of Southern submit a report to the Chancellor of the Connecticut State University System evaluating the performance of the Center and recommending continuance or discontinuance by September 1, 2006, and be it further
- RESOLVED, That the Center for the Environment at Southern Connecticut State University shall go out of existence on December 31, 2006, unless the Board of Trustees acts to the contrary.

ITEM

Continuation of the Center for the Environment at Southern Connecticut State University

BACKGROUND

The Center for the Environment at Southern was established in 1989 to house instructional and research events and opportunities in marine and environmental studies as well as science education. It was designated as a Center by the Board of Trustees in 1989 and continued in 1994 and again in 1997. The work of the Center helped develop the Department of Science Education and Environmental Studies, which now houses all academic programs; the Center itself is responsible for research initiatives, field sites and community projects.

ANALYSIS

Via SCSU's Center for the Environment, Connecticut State University has exclusive control of educational programs and projects on Outer Island. Last year, an 86 acre parcel of land in Potsdam NY was donated to the Center for use as a second field site and retreat. Since its inception, faculty from the Center have worked with schools, community members and nonprofit organizations to develop and expand educational programs on Outer Island. Since 1998, more than 1600 individuals visited Outer Island for educational purposes. The Center sponsors conferences, symposia and community events, including latest a biodiversity research symposium in spring 2000.

Plans for the future include development and maintenance of the field sites and the expansion of community activities, symposia and seminars. There are plans for funding initiatives to support research and educational activities. The university provides continuing operational support.

CHANCELLOR'S RECOMMENDATION

Accept the report of the President of SCSU to continue the Center for the Environment and require an evaluation of the continuing operation of the Center, including a financial report, by September 1, 2006. A sunset date of December 31, 2006 will be in force if the Center is not recommended for continuance.
