RESOLUTION

concerning

THE USE OF DESIGNATED FUND BALANCES TO FUND THE INSTALLATION OF PERMANENT LIGHTING AT ARUTE FIELD AT CENTRAL CONNECTICUT STATE UNIVERSITY

July 19, 2002

- WHEREAS, As part of Central Connecticut State University's ongoing commitment to upgrade intercollegiate athletics, intramurals and recreation, it is necessary to install permanent lighting at Arute Field at Central Connecticut State University (CCSU), and
- WHEREAS, The University has received a final bid of \$284,447 for the lighting upgrade, and
- WHEREAS, Due to the urgency in beginning the installation, on July 2, 2002, via electronic vote, the Executive Committee, on behalf of the Board of Trustees, authorized CCSU to use up to \$285,000 from their designated fund balances for the installation of permanent lighting at Arute Field at CCSU, therefore be it
- RESOLVED, That the Board of Trustees for the Connecticut State University System ratifies the July 2, 2002, action of the Executive Committee.

The use of designated fund balances to fund the installation of permanent lighting at Arute Field at Central Connecticut State University (CCSU).

BACKGROUND

The designation of unrestricted fund balances for specific projects under \$250,000 at a university is authorized by Board policy. Expenditures exceeding this amount require Board approval. Of particular note is that CCSU's undesignated fund balance meets the requirements of the Board's fund balance guidelines.

ANALYSIS

As part of Central Connecticut State University's ongoing commitment to upgrade intercollegiate athletics, intramurals and recreation, the university, over a year ago, requested, and the Board approved, an athletic fee.

One of the key areas for upgrade to intramural and recreation activities was equipment and lighting for playing fields. Central has set aside \$64,000 for fitness equipment upgrades and received a final bid of \$284,447 for the lighting upgrade.

The University has set aside over \$300,000 in the Plant Fund for field lighting improvements and is seeking approval from the Board to finalize the project. It is urgent that funding be in place to award this bid in order to contain costs and for the project to be completed before the beginning of the new academic year.

In order to meet this deadline, on July 2, 2002, the Executive Committee via electronic vote, on behalf of the Board of Trustees, authorized CCSU to use up to \$285,000 from their designated fund balances for the installation of permanent lighting at Arute Field.

As required by Board policy, the full Board must ratify the action of the Executive Committee at the July 19, 2002, Board meeting.

As part of Central Connecticut State University's ongoing commitment to upgrade intercollegiate athletics, intramurals and recreation, the University, over a year ago, requested, and the Board approved, an athletic fee.

One of the key areas for upgrade to intramural and recreation activities was equipment and lighting for playing fields. The University has set aside \$64,000 for fitness equipment upgrades and we have received a final bid of \$289,000 for the lighting upgrade. This bid exceeds the \$250,000 plant fund Board Resolution guideline. As part of the discussions with the Board, it is pointed out that presently intercollegiate athletics spends over \$40,000 annually in light rental fees.

The University has set aside over \$300,000 in the Plant Fund for field lighting improvements and is seeking approval from the Board's Executive Committee to finalize the project. There is an urgent need to finalize this deal in order to contain costs and for the project to be completed before the beginning of the new academic year.

I am requesting that the Executive Committee of the Board approve the expenditure of \$289,000 from the Plant Fund for playing fields lighting upgrade.
