

The Commission for Higher Education, subject to its responsibility contained in Section 6 of Public Act 751, in which Commission approval is necessary for leasing of physical facilities required by the Board of Trustees for the State Colleges, hereby adopts the following resolution.

RESOLVED: That approval is hereby given the request of the Board of Trustees for the State Colleges to lease on a three-year basis for Central Connecticut State College for the housing of students, apartments located at 24 Peck Street, New Britain, owned by Mr. Benjamin Price (c/o George Bernstein Associates, 223 Main Street, New Britain, Connecticut), containing approximately 24,000 square feet of living area. This will accommodate 150 students who will pay a per semester rental of \$237.50.

This Resolution is approved with the proviso that the housing remain on a self-liquidating basis and that negotiations for and acquisition of the property requires the participation and approval of the Public Works Department and the Office of Finance and Control.
