AUTHORIZING RESOLUTION

concerning

On-Campus Dormitory Fees

April 3, 1970

WHEREAS, it is recognized that operating costs vary with different types of traditional, on-campus student housing facilities, and

WHEREAS, it is recognized that increased operating costs make an increase in student dormitory fees necessary in some types of facilities,

BE IT RESOLVED, that subject to the approval of the Commission for Higher Education, the student dormitory fee for traditional, on-campus dormitory accommodations be increased as herein tabulated to be effective not later than September 1, 1971.

Subject: Resolutions Related to Increasing Room and Board Fees at State Colleges


At its regular meeting on June 2, 1970, the Fiscal Policy Committee of the Commission for Higher Education reviewed two resolutions submitted by the State Colleges' Board of Trustees:

1. That approval be given to the Board of Trustees to increase the fee for the Student Food Plan to \$520 per academic year, with the date of implementation to be at the discretion of each college and
2. That approval be given to the Board of Trustees to increase the student dormitory fee to \$375 for single occupancy; \$350 for double occupancy; \$325 for triple occupancy; and \$300 for quadruple occupancy, with the date of implementation to be at the discretion of each college.

After consideration, the Fiscal Policy Committee recommended to the Commission that for the 1970-71 academic year adjustments could be made by the constituent units in fees set to operate auxiliary services, including room and board, when such adjustments were required to maintain the self-liquidating operation of the enterprise, subject to prior confirmation by the staff of the Commission that such adjustment in fees was required. This action was approved by the Commission. Approval was thereby given to the resolutions cited above.

RESOLVED that the Commission for Higher Education, subject to its responsibilities contained in Public Act 530 (1969) authorize constituent units during the 1970-71 fiscal year to make such adjustments in the fees and rates set to operate self-liquidating projects as are required to maintain their self-liquidating character, subject to determination by the Commission's staff that such adjustment is necessary to maintain a reasonable standard of service to the students and other users.
