RESOLUTION OF THE BOARD OF TRUSTEES FOR THE STATE COLLEGES TO APPLY FOR SURPLUS PROPERTY FROM THE FEDERAL DEPARTMENT OF HEALTH, EDUCATION & WELFARE

February 4, 1972

WHEREAS, the Board of Trustees for the State Colleges upon the advice and consent of the Governor, as required by Public Act No. 17 of the 1971 Session of the General Assembly, is empowered to acquire properties,

WHEREAS, the Federal Department of Health, Education, and Welfare has offered 71 acres, identified as tract 165 on the town map of West Thompson, Connecticut on Messier Road, to be used for educational purposes under a United States Government Surplus Land Grant,

WHEREAS, said property can be utilized to great advantage in the biology and Earth Science programs of Eastern Connecticut State College,

BE IT RESOLVED, that the Board of Trustees for the State Colleges hereby approves the filing of an application to obtain said property, contingent upon the consent of the Governor of the State of Connecticut.

RESOLVED that the Commission for Higher Education, subject to its responsibilities contained in Sections 10-109b and 10-324 of the General Statutes, approves action taken by the Board of Trustees for State Colleges to acquire from the U. S. Government approximately 71 acres of vacant land, identified as Tract 165, a portion of the West Thompson Lake Project, located on Messier Road, West Thompson, Connecticut, to be utilized to strengthen instructional programs at Eastern Connecticut State College, with the conditions that within the limitations for use specified in the application: (a) utilization of the property be made available to other interested educational units, including secondary education, (b) other state agencies be permitted to use the facility, and (c) no documents restricting or expanding permissable use be submitted to the donor agency, within the 30 years of conditional use, unless first approved by the Commission for Higher Education.

PUBLIC ACT NO. 17

AN ACT CONCERNING PURCHASE, SALE OR EXCHANGE OF LAND WHEN THE GENERAL ASSEMBLY IS NOT IN SESSION.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

Section 4-26 of the 1969 supplement to the general statutes is repealed and the following is substituted in lieu thereof: The trustees of any state institution [or], the state board of education OR THE COUNCIL OF CORRECTION may, with the advice and consent of the governor, purchase or acquire for the state any land or interest therein when the general assembly is not in session, if such action seems advisable to protect the state's interest or to effect a needed economy, and may, when the general assembly is not in session, with the advice and consent of the governor, contract for the sale or exchange of any land or interest therein belonging to the state. The governor, when the general assembly is not in session, may give or obtain an option upon any land or interest therein which is not under the control of the trustees of any state institution [or] the state board of education OR THE COUNCIL OF CORRECTION when such action seems advisable, and such option shall remain in force until the first Wednesday of March of the next session of the general assembly. The treasurer shall execute and deliver any deed or instrument necessary to convey the title to any property the sale or exchange of which or a contract for the sale or exchange of which is authorized by this section.

- 3. This institution is an instrumentality (or political subdivision) of the State of Connecticut.
- 4. The State of Connecticut will not discriminate because of creed in the use of any portion of this property.
- 5. This application is being made for acquisition of the property under the provisions of Section 203(k) (1) of the Federal Property and Administrative Services Act of 1949, (63 Stat. 377), as amended, and regulations and procedures promulgated thereunder.
- 6. The property applied for is as follows: "Tract 165, a portion of the West Thompson Lake Project, located on Messier Road, West Thompson, Connecticut" has been determined to be surplus government property. The surplus area consists of approximately 71 acres and is vacant land. The center portion contains 45 to 50 acres stripped of all topsoil and subsoil. The north, south and western boundaries are heavily wooded tall pine with the eastern boundary containing a narrow strip of small deciduous growth.

7. PLAN OF USE:

The land will be utilized to strengthen instructional programs in the Department of Biology and in the Earth Science Area of the Department of Physical Science.

The value of this property to the biology program of Eastern Connecticut State College lies principally in its undeveloped nature; this feature would be maintained, with no permanent structural development of any kind contemplated.

A present weakness of the Eastern Connecticut State College biology program is its lack of property where long-range terrestrial studies may be conducted. This property would serve this need, permitting a wide variety of field programs to be expanded or developed. Ease of accessibility but lack of through traffic enhances the usefulness of the area for such programs.

The area under consideration provides a wide range of ecological conditions ranging from marsh to well-drained, open grass to well-forested, areas devoid of topsoil to areas with well-developed soil profiles, including forests of mixed species as well as areas of relatively pure conifer and pure deciduous growth. Such variety of conditions makes possible a wide spectrum of short- and long-ranged biological studies.

The land will be utilized by the Biology Department in the following manner:

- 1. Immediate initial survey and mapping of property boundaries, vegetation types, and ecological areas and soil types.
- 2. Selection of subareas for the following studies:
 - a. Plant Succession. Areas stripped of topsoil which are now in initial stages of plant succession.
 - b. Soil Profile Development. The effect of plant growth and succession in areas where no soil profile exists due to excavation.
 - c. Vegetational Changes under Natural Conditions. Designation of an area of approximately 10 acres encompassing a variety of conditions. No manipulation of any kind to be permitted. Ecological conditions of this area could be then compared to areas in which man-made changes might occur due to study and usage.
 - d. Microclimate Variability. Use of temporary stations to study the wide range of conditions of moisture, forest types, and grass vegetation.
 - e. Growth Studies. Growth studies of all diameter classes of a wide variety of forest trees.
 - f. Natural History. General natural history studies and observations encompassing grasses, trees, flowers, birds, and small mammals.

The undergraduate and graduate programs of the Earth Science Area in the Physical Science Department will utilize this tract of land for basic instruction in geological surveying and mapping methods and for soil study techniques.

The cited uses of the land will be conducted or supervised by at least five members of the staffs of the Biology and Physical Science Departments. It is anticipated that approximately 300 to 500 students as members of six to eight courses will participate in the cited activities each year during both regular school year and summer sessions. Individual students will conduct special project studies on the area, principally as part of the special problems course required of all biology students at Eastern Connecticut State College. This would involve year-round use of the area and all of its natural habitats. In addition, the area will be available for science field trip activities for the lower and middle elementary science classes from the F. R. Noble Community School of Eastern Connecticut State College.

The proposed programs and usage of the area will not conflict with local or state land use regulations.

The proposed usage of the land will commence as of June 1972, or upon date of acquisition if later than June 1972.

The current approximate undergraduate and graduate enrollment of Eastern Connecticut State College is 3000. Approximately 300 to 500 students will utilize the land each year under the proposed uses.

 The current operational budget of Eastern Connecticut State College is approximately \$4,117,000.00 per annum.

The combined current operational budgets for equipment, supplies etc. for the Departments of Biology and Physical Science is approximately \$15,000.00. Normal administrative allocation of operational funds within the departments will allow usage of the land for the purposes cited.

9. At present the Biology Department offers programs in General Biology, Marine Biology, Ecology, and Biology Minors in the field of Education. The Physical Science Department offers concentrations in Earth Science, Physical Science, and Chemistry. Laboratory and classroom facilities are available for the conduct of these programs. Acquisition of the land would enable the Department of Biology to expand and strengthen course offerings in the area of Terrestrial Biology, Ecology, and General Biology. The Earth Science Area of the Physical Science Department would benefit by the possession of a permanent area for instruction in basic field methods.

Eastern Connecticut State College is accredited by the National Council for Accreditation of Teacher Education and the New England Association of Schools and Colleges.

- 10. Ideally suited for the biological purposes mentioned, the property applied for provides a wide range of terrestrial ecological habitats and conditions such as natural forested areas of a variety of types and species, natural and disturbed soils, and the beginnings of vegetative succession in the disturbed areas. The tract of land is also reasonably isolated and bounded by large undisturbed forests which will allow its maintenance in this condition and affords free natural interchange of fauna of the region. The paved road to, but not through, the area ensures accessibility for year-round studies and class uses. Its distance from the main campus allows reasonable accessibility for the proposed uses. But it is also far enough removed from the campus to preclude general usage by non-supervised groups.
- 11. The property will be utilized in the manner proposed for the next thirty years.

Eastern Connecticut State College requests permission to apply for a United States Government Surplus Land Grant, described as follows:

Tract 165, a portion of the West Thompson Lake Project, located on Messier Road, West Thompson, Connecticut. The surplus area consists of approximately 71 acres and is vacant land. The center portion contains 45 to 50 acres stripped of all topsoil and subsoil. The north, south, and western boundaries are heavily wooded tall pine with the eastern boundary containing a narrow strip of small deciduous growth.

PLAN OF USE:

If conveyed to the State for educational use, the land will be utilized to strengthen instructional programs in the Department of Biology and in the <u>Earth Science Area</u> of the Department of Physical Science.

A. Biology

The value of this property to the biology program of Eastern Connecticut State College lies principally in its undeveloped nature; this feature would be maintained, with no permanent structural development of any kind contemplated. Thus the need to avoid future expenses for the State coincides with the need for biology students to work with the raw land. A present weakness of the Eastern Connecticut State College biology program is its lack of property where long-range terrestrial studies may be conducted. This property would serve this need, permitting a wide variety of field programs to be expanded or developed. Ease of accessibility but lack of through traffic enhances the usefulness of the area for such programs.

The area under consideration provides a wide range of ecological conditions ranging from marsh to well-drained, open grass to well forested, areas devoid of topsoil to areas with well-developed soil profiles, including forest of mixed species as well as areas of relatively pure conifer and pure deciduous growth. Such variety of conditions makes possible a wide spectrum of short- and long-ranged biological studies. The land will be specifically utilized by the Biology Department in the following manner:

1. Immediate initial survey and mapping of property boundaries, vegetation types and ecological areas and soil types.

2. Selection of sub-areas for the following studies:

- a. <u>Plant Succession</u> Areas stripped of topsoil which are now in initial stages of plant succession.
- b. <u>Soil Profile Development</u> The effect of plant growth and succession in areas where no soil profile exists due to excavation.
- c. Vegetational Changes under Natural Conditions Designation of an area of approximately 10 acres encompassing a variety of conditions. No manipulation of any kind to be permitted. Ecological conditions of this area could be then compared to areas in which man-made changes might occur due to study and usage.
- d. <u>Microclimate variability</u> Use of temporary stations to study wide range of conditions of moisture, forest types and grass vegetation.
- e. Growth Studies Growth studies of all diameter classes of a wide variety of forest trees.
- f. Natural History General natural history studies and observations encompassing grasses, trees, flowers, birds, and small mammals.

B. Earth Science

The undergraduate and graduate programs of the earth science area in the Physical Science Department will utilize this tract of land for basic instruction in geological surveying and mapping methods and for soil study techniques.

The above-mentioned uses of the land will be conducted or supervised by at least five members of the staffs of the Biology and Physical Sciences Departments. It is anticipated that approximately 300 to 500 students as members of six to eight classes will participate in the various educational activities each year during both regular school year and summer sessions. Individual students will conduct special project studies of the area. In addition, it is anticipated that the area will be used by teacher-led groups from the F. R. Noble Elementary School of Eastern Connecticut State College and summer groups such as members of the Federated Garden Clubs of America Ecology and Environmental Problems Workshop.

C. General Considerations


At present the Biology Department offers programs in General Biology, Marine Biology, Ecology, and Biology Minors in the field of Education. The Physical Science Department offers concentrations in Earth Science, Physical Science and Chemistry and is developing undergraduate and graduate programs in Earth Science. Facilities are available for the conduct of these programs. The acquisition of the land would enable

the department to expand and strengthen course offerings in the area of terrestrial biology, ecology and general biology. The earth science area of physical science would benefit by the possession of a permanent area for basic field methods.

The paved road to, but not through, the area ensures accessibility for year-round studies and class uses. Its distance from the main campus also allows reasonable accessibility for the proposed uses but is also far removed enough from the campus to preclude general usage by non-supervised groups. As the property will be utilized in field oriented courses and projects, transportation and access to the property by students or other groups will be effected by usual procedures for such activities.



- Long-range study (10 acres) on rejuvenation of soil profile and vegetational succession.



This Department can transfer the following surplus Government-owned real property to public educational or health institutions under the provisions of Section 203 (k) (1) of the Federal Property and Administrative Services Act of 1949, as amended, at public benefit allowances ranging up to 100%.

Tract 165, a portion of the West Thompson Lake Project, located on Messier Road, West Thompson, Connecticut, has been determined to be surplus Government property. The surplus area consists of approximately 71 acres and is vacant land. The center portion contains 45 to 50 acres stripped of all topsoil and subsoil. The north, south and western boundaries are heavily wooded tall pine with the eastern boundary containing a narrow strip of small deciduous growth.

Transfers for use in health or educational programs may be made to States, their political subdivisions and instrumentalities, tax-supported institutions or educational and public health institutions which have been held exempt from taxations under Section 101(6) of the Internal Revenue Code of 1939 (now substantially renacted in Section 501(c)(3) of the Internal Revenue Code of 1954). Public libraries, institutions whose activities are devoted to academic, vocational or professional instruction, or institutions organized and operated to promote the public health, are eligible. Examples of use for property of this type are outdoor recreation, vocational, agricultural, and ecological studies.

If your institution is interested in applying for all or a portion of this property, it is suggested that you notify this office before December 15, 1971, relating briefly your proposed use. You will then be furnished a guide which will assist you in preparing your application.
