Dear Dr. Smith:

At its regular meeting on June 6, 1972, a quorum being present and voting, the Commission for Higher Education approved the resolutions attached:

1. Authorization to increase room and board charges at the State Colleges, effective fall, 1972.
2. Authorization to increase the credit hour charge for courses offered in the Education Extension and the Summer Session, at the State Colleges, effective fall, 1972.
- ✓ 3. Authorization to increase the applied music fee at Central Connecticut State College.

It is understood that each of these three authorized increases must meet Federal Price Commission Regulations that are currently applicable.

The Commission also approved an agreement between the Public Works Department of the State of Connecticut and the Department of Public Works of the City of New Haven concerning the improvement of the sanitary sewer system serving Southern Connecticut State College.



It is anticipated that 60 hours of private lessons per week will be taught to meet the needs of the 85 students. The full-time music department faculty will teach 29 hours of these private lessons as part of their normal load. The balance of 31 hours of weekly private music lessons will be taught by part-time faculty at an average rate of \$9 per hour. During the 1972-73 academic year, it is estimated that 279 hours of private music lessons will be taught by part-time faculty. The current applied music fee of \$25 will provide for only 140 hours of private music lessons taught by part-time faculty. The full-time faculty cannot assume this load and many of the part-time faculty give lessons in areas in which our full-time faculty do not have the high degree of competency required to be a competent teacher.

Dear Don:

At its last meeting the Board of Trustees adopted a resolution approving the increase in the Applied Music fee to \$50 per semester for Music Education major students and \$50 per semester hour for other students who are taking Applied Music courses.

We have not yet sent this to the Commission for Higher Education (CHE) for ratification at its meeting next month. Before doing this would you give me a full one paragraph justification of why the fee had to be increased — something more than the general statement which appears in the attached copy of your letter. How much do lessons cost? How much did they cost two years ago?

I regret asking for details on a matter that the CHE might be expected to accept on faith but our antennae tell us that the day is over, at least for the present period, when we can give a general or narrative justification for increasing costs. They seem to want to know the details.

This is to request that the following resolution be placed on the agenda of the Planning Committee of the Board of Trustees for its meeting on April 27 and, with its approval, on the agenda for the Board at its meeting on May 5.

RESOLVED, that effective September 1, 1972, an applied music fee of \$50 per semester for Music Education major students, and \$50 per semester of applied music for all other students is authorized at Central Connecticut State College.

The Music Education majors are required to take seven semesters of private music lessons to meet graduation requirements. It is anticipated that approximately 50 Music Education majors and 35 other students will be taking private music lessons in the fall semester of the 1972-73 academic year.

The money received from this Applied Music Fee will be used to compensate part-time faculty who will teach some of these private lessons.
