

Dear Dr. Haas:

The Commission for Higher Education, at the time of a meeting held on March 7, 1972, approved the following Resolution:

"RESOLVED, that the Master of Arts Program in History at Western Connecticut State College be accredited for a period generally coinciding with the institution's current undergraduate and graduate accreditation by the New England Association of Schools and Colleges extending to June 30, 1974."

Enclosed are twenty copies of the report. Another twenty copies are being sent to Dr. J. Eugene Smith at the office of the Board of Trustees for State Colleges.

The Standing Committee on Accreditation, at the time it reviewed the report of the college and consultants, noted that the strength of this program will be related to an improvement of pertinent library resources. Consequently, the Standing Committee recorded an observation in its minutes that particular attention should be given to the question of library resources when the program leading to the degree of Master of Arts in History is next evaluated.
