RESOLUTION

concerning

FACULTY EXCHANGE

CENTRAL CONNECTICUT STATE COLLEGE

March 2, 1973

- WHEREAS, the Board of Trustees for the State Colleges is required to "...administer the state colleges...." and to have sole jurisdiction over the "...assignment of duties...." of the state college personnel (Sections 10-109b and 10-329a of the General Statutes)
- BE IT HEREBY RESOLVED, that the Board of Trustees authorizes the professorial exchange of Dr. George Muirhead of Central Connecticut State College and Mr. Emrys Owen, Senior Lecturer at Bingley College, Yorkshire, England, under the following conditions:
  - 1. The exchange to be for the academic year 1973/74 only.
  - 2. Bingley College of Education will reimburse Mr. Emrys Owen his normal salary and Central will reimburse Dr. George Muirhead his salary for the year.
  - 3. In addition Mr. Owen will receive from Central compensation for 9 hours as Lecturer II in the Evening College, because of the differences in salary amounts.

Dear Jim:

This is to request that you place on the agenda for the Personnel Committee meeting on February 26, an item from Central Connecticut State College regarding a Professorial Exchange involving Dr. George Muirhead of our College and Mr. Emrys Owen, Senior Lecturer at Bingley College, Yorkshire, England.

The following conditions will govern this exchange:

- 1. The exchange will be for one academic year only.
- 2. Bingley College of Education in England will reimburse Mr. Emrys Owen his normal salary and Central will reimburse Dr. George Muirhead his salary for the academic year.
- 3. Because of the great differences in salary amounts, Mr. Owen will receive nine hours as Lecturer II in the Evening College while in service here. This would represent Mr. Owen not only carrying Dr. Muirhead's normal load in the Day Program, but also the additional nine hours to assist him in living expenses, six of which will be in instruction.

I would request approval by the Personnel Committee and the Board for this exchange which involves the appointment of Mr. Emrys Owen for the 1973-74 academic year. Dean Clow will be discussing this exchange with the appropriate officials in the State to work out the necessary arrangements there.
