
Whereas there is a roadway entering the South Campus and whereas this roadway is an extension of Windham Street

Whereas the improvement of this field is being encouraged by alumni of Eastern Connecticut State College and


Whereas this field preserves many pleasant memories of athletic contests of years gone by

Whereas Building Project BI-RW-376 has been completed on the campus of Eastern Connecticut State College and


Whereas this building is used primarily for the purposes of teaching Health, Physical Education, Recreation, and Sports
