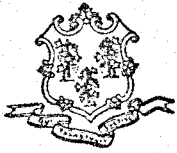

WHEREAS, An exchange of teachers with foreign institutions provides enrichment of educational programs, be it

RESOLVED, That under the authority granted by Sections 10-109b and 10-329a of the General Statutes, the Board of Trustees for the State Colleges of Connecticut authorized an exchange of teachers involving Mr. J. R. Fernandez of Central Connecticut State College and Miss Elizabeth A. Stevens, a member of Dundee College of Education, Dundee, Scotland. The said exchange to be subject to the following conditions:

- A. The salary of Mr. Fernandez shall be paid by Central Connecticut State College
- B. The salary of Miss Stevens shall be paid by Dundee College
- C. The exchange shall be for the academic year 1974-1975 and subject to provisions included in the attached March 11, 1974, letter from President F. D. James of Central Connecticut State College to Miss D. Stewart.

I am pleased to furnish you the information requested in your letter of March 1, to Vice President C. A. Clow, Central Connecticut State College regarding the exchange between our staff member Mr. J. R. Fernandez and Miss Elizabeth A. Stevens of the United Kingdom.


