RESOLUTION

concerning

THE GRANTING OF A LICENSE TO THE CITY OF DANBURY

FOR THE USE OF LAND AT WESTERN CONNECTICUT STATE COLLEGE

APRIL 11, 1975

WHEREAS, The City of Danbury has shared its community facilities with Western Connecticut State College, and

WHEREAS, The City of Danbury and Western Connecticut State College enjoy a relationship of cooperation and amicability, and

WHEREAS, A portion of the new campus property may be used temporarily by the City of Danbury for a children's playground without infringement upon college activities, therefore be it

RESOLVED, That the Board of Trustees authorizes a license to be granted to the City of Danbury for the use of the approximately two-acre portion of land identified in Exhibit A for the purpose of a children's playground, provided Western Connecticut State College, the Trustees, and the State of Connecticut are held harmless from all claims and provided that the license to use the property may be terminated at the will of the Board of Trustees and that upon such termination the City of Danbury will return the site to a condition satisfactory to the Trustees. The terms of the license shall be subject to the approval of the State Attorney General and the plans subject to the approval of the Commissioner of Public Works.

My dear Attorney General:

The Mayor of the City of Danbury has requested permission to use, on a temporary basis, about two acres of land on the site of the College's proposed new campus. A copy of his letter is attached.

The area which is indicated on the partial map attached is not reserved for immediate building construction. It is part of the section of the campus which will ultimately be used for outdoor physical education facilities according to the Master Plan.

The City has always been most cooperative in extending to the College the use of City facilities such as the City playing field now used each season by the College's football teams. Therefore, it would be fitting if this request of the City's could be granted. The College recommends that the City of Danbury be permitted temporary use of the area as requested to be terminated at the pleasure of the State when advancing construction will place demands on the space.


