FOR 1975-1976

June 13, 1975

WHEREAS, The General Assembly has declared that, because of the stringent fiscal situation, there shall be no promotions for classified personnel, and

WHEREAS, The 1975-1976 appropriations made by the General Assembly do not adequately provide for the personal services needed by the State Colleges, therefore be it

RESOLVED, That, in view of the difficult financial situation, no sabbatical leaves shall be granted during the academic year 1975-1976, and be it further

RESOLVED, That no promotions shall be made during the academic year 1975-1976.



Dear Dr. Frost:

On behalf of the Faculty Senate at CCSC, I am transmitting two items for the information of the Trustees.

1. A Promotions Resolution. I want the Trustees to know that the faculty are enormously frustrated by the current level of promotions. Many feel they have fulfilled a real obligation in earning degrees and otherwise qualifying themselves for higher academic rank. Now, they find promotions which should follow such attainments long delayed and frequently denied. Younger faculty are particularly upset because they find they would have been paid more adequately if they chose to teach in the secondary schools of the state. Additional costly education suitable for college level qualifications is not rewarded.

Our faculty understand that the Trustees also are frustrated in their inability to deliver adequate incentives for maintaining an adequate state college faculty. Perhaps this resolution and letter will be of service to them in quest of additional resources.

Faculty members would be favorably impressed if the Trustees would raise these issues in a public way to lay before the state's citizenry the sorry plight of our personnel.

2. We have set in motion a committee to recommend merit pay policy to the Trustees. This follows a preliminary senate study on the matter and is undertaken for the purpose of advising the Trustees as they have requested. I hope they will await the results of this activity which continues to follow a realistic time schedule.



- Whereas, Promotion is the measure by which academic excellence is recognized; and
- Whereas, The limited number of promotions and the withholding of promotions has adversely affected faculty morale at The State Colleges; and
- Whereas, The Trustees of the University of Connecticut have recently granted a considerable number of faculty promotions; now, therefore, be it
- Resolved, That the Senate President write to The Board of Trustees for The State Colleges requesting a firm commitment to award adequate numbers of promotions on a regular basis; and, be it further
- Resolved, That President James give his continued support to an adequate promotions policy.

Dear President Haas:

On April 4, 1975, you notified the faculty at Western Connecticut State College that there will be no promotions in rank for the 1975-76 academic year in any of the four state colleges. The reason given for the decision was the stringent limitations placed on our budgets.

As chairmen of the academic departments at Western, we wish to protest this action strongly. This is another example of the causes for low morale among the faculty. Our salary scales remain low and non-competitive, and promotion and tenure are the only tangible rewards available to indicate to faculty that they are doing well. Both of these, tenure and promotions, have been consistently withheld for the past few years: a problem of budget is always the excuse, but is never resolved to any degree by the Board.

We are aware that the State University has the financial resources to grant up to 100 promotions for the 1975-76 academic year, despite "stringent limitations" on its budget. We do not understand why the Board of Trustees for the State Colleges can not in some way manage to find the money to promote those who are long overdue for recognition of their quality efforts in teaching at the state colleges. The money involved appears insignificant, in comparison to the potential benefit to the colleges.

Our Promotions Committee, aware of its serious responsibility, have worked together in regular meetings over the past five months in an effort to present you with a list of faculty it believes is deserving of promotion. The effects of this directive have been devastating.

As chairmen, we believe in our faculty and their worth. We can not in good conscience support this no-promotion policy. We believe the Board of Trustees should support us in our efforts to allow promotions. We can see no justification for their refusal to do so.
