

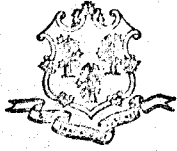
WHEREAS, The State of Connecticut acquired various pieces of property for the planned expansion of the Central Connecticut State College campus, and
