Dear Jim:

This June, Dr. Helen Rakieten of our Education Department is being forced into mandatory retirement. She will then have completed ten years of full-time service. From September 1949 through the summer of 1961 she served continuously as a part-time instructor at Southern. During her last decade at Southern she served not only as a professor but also as department chairman and interim dean of professional studies. Hers has been a distinguished career in education and no one has been more conscientious in the fulfillment of her responsibilities to the college than she. She is well-beloved by generations of undergraduate and graduate students.

Our personnel policies require fifteen years of service to qualify as an emeritus professor; they also provide that exceptions may be made by the Trustees. I request that the Personnel Committee of the Trustees be asked to make an exception in her case and permit the awarding of emeritus status to her.

If you agree that this request may be placed on the agenda of the Personnel Committee, please let me know and I'll prepare a more detailed summary of her career for their consideration. As public school teacher and administrator, as professor and administrator at Southern, she has accomplished without benefit of Women's Lib what many modern your women believe they can achieve only through the enforcement of affirmative action principles.
