WHEREAS, An exchange of teachers with other institutions provides enrichment of educational programs, be it

RESOLVED, That under the authority granted by Sections 10-27, 10-109b and 10-329a of the General Statutes, the Board of Trustees for the State Colleges of Connecticut authorizes an exchange of teachers involving Dr. Stephen Kenton, Associate Professor in the Mathematics Department at Eastern Connecticut State College and Dr. Paul Murphy, faculty member of California Polytechnic State University at San Luis Obispo, California.

- a. The salary of Dr. Kenton shall be paid by Eastern Connecticut State College.
- b. The salary of Dr. Murphy shall be paid by California Polytechnic State University.
- c. Transportation, lodging, and other personal expense incurred in the exchange will be fully assumed by the individuals involved.
- d. Dr. Murphy will report to the Chairman of the Department of Mathematics of Eastern Connecticut State College at the beginning of the fall semester and will assume Dr. Kenton's teaching assignments.

Dr. Kenton will assume Dr. Murphy's teaching assignments in the area of Mathematics at California Polytechnic State University.

e. The exchange shall be for the academic year 1976 - 1977.

That under the authority granted by Sections 10-27, 10-1098 and 10-329a of the General Statutes, the Board of Trustees for the State Colleges of Connecticut authorizes an exchange of teachers involving Dr. Paul Murphy, faculty member of California Polytechnic State University at San Luis Obispo, California, and Dr. Stephen Kenton, Associate Professor in the Mathematics Department at Eastern Connecticut State College. The said exchange to be subject to the following conditions:

- A. The salary of Dr. Kenton shall be paid by Eastern Connecticut State College.
- B. The salary of Dr. Murphy shall be paid by California Polytechnic State University.
- C. Transportation, lodging, and other personal expense incurred in the exchange will be fully assumed by the individuals involved.
- Dr. Murphy will report to the Chairman of the Department of Mathematics of Eastern Connecticut State College at the beginning of the fall semester and will assume Dr. Kenton's teaching assignments.

Dr. Kenton will assume Pr. Murphy's teaching assignments in the area of Mathematics at California Polytechnic State University.

AGREEMENT FOR EXCHANGE OF FACULTY

In consideration of mutual benefits to be gained by exchange of faculty,
Dr. Paul Murphy, faculty member of California Polytechnic State University
at San Luis Obispo, California (hereinafter Cal Poly) and Dr. Stephen Kenton,
faculty member of Eastern Connecticut State College (hereinafter Eastern
Connecticut) agree as follows:

- 1) Dr. Paul Murphy will serve as a full-time faculty member at Eastern Connecticut during the academic year of 1976-77 under the direction of the chairman of the Mathematics Department, the Vice-President for Academic Affairs and other duly designated officers at Eastern Connecticut, and subject to the regulations governing aculty at Eastern Connecticut.
- 2) Dr. Stephen Kenton will serve as a full-time faculty member at Cal Poly during the academic year of 1976-77 under the direction of the head of the Mathematics Department, the Dean of the School of Science and Mathematics and other duly deisgnated officers at Cal Poly, and subject to the regulations governing faculty at Cal Poly.
- 3) Cal Poly will pay Dr. Paul Murphy his full salary for the academic year 1976-77 in accordance with the established salary schedule at Cal Poly just as if he were on full-time duty at Cal Poly.
- 4) Eastern Connecticut will pay Dr. Stephen Kenton his full salary for the academic year 1976-77 in accordance with the established salary schedule at Eastern Connecticut just as if he were on full-time duty at Eastern Connecticut.
- 5) Dr. Paul Murphy will continue to enjoy the privileges of faculty status at Cal Poly as if he were in continuous residence at Cal Poly.

- 6) Dr. Stephen Kenton will continue to enjoy the privileges of faculty status at Eastern Connecticut as if he were in continuous residence at Eastern Connecticut.
- 7) Dr. Paul Murphy will be subject to the laws of the State of Connecticut governing workers.
- 8) Dr. Stephen Kenton will be subject to the laws of the State of California governing workers, including the Workers' Compensation Law.
- 9) By the 20th of each month an attendance report by the Mathematics department, Eastern Connecticut, shall be submitted to the Dean of the School of Science and Mathematics at Cal Poly for Dr. Murphy.
