

Attached is a copy of the text of a proposed resolution whereby the Board of Trustees for the State Colleges extend their existing policy concerning transfer of students who have earned an associate degree.

The proposed resolution comes to you with a request that it be presented to the State College Board for approval.

The proposed resolution was placed before the Board for State Academic Awards on the recommendation of a special subcommittee of the Board's Faculty of Consulting Examiners and was approved in principle by unanimous vote at a meeting on December 11, 1975. A copy of the Board's action is also attached.

The approval was given "in principle and subject to final action" rather than outright in order to facilitate editorial or technical changes. Individual members of the Board expressed great enthusiasm and asked that the following statement be recorded in the minutes:

That the Board attaches particular importance to the establishment of articulation agreements with the state university, state colleges, and other baccalaureate-granting institutions; hence that every effort should be made to establish suitable agreements as soon as possible.

The Board believes that the resolution offers a double advantage in that external degree graduates will be assured of access to Upper Division programs within the public system while the receiving institutions will benefit from a uniform basis for admitting such graduates.

Please call upon me if further information is needed. We shall be grateful for your help.

Frequently work requirements for non-instructional faculty cannot be met by the standard hours of work of seven per work day and thirty-five per work week. When work requirements cannot be met by the standard hours of work of seven per work day and thirty-five per work week, the President may authorize a work week which shall average seven hours per workday and thirty-five hours per work week during a period of not more than eight weeks. The eight-week period will begin at the time the authorized change from the standard work week begins.

Positive attendance records will be maintained for all non-instructional faculty.
