

- WHEREAS, The Board of Trustees for State Colleges desires to confirm by resolution a policy which was instituted with the initiation of the self-liquidating program for dormitory construction, and

Your telephone response to my memorandum of May 27, 1976, on the subject of the Fees Fund did not completely answer the questions in my mind relative to the statutory authority for the establishment of the Fees Fund and the Sinking Fund nor the question of the authority conferred upon yourself to initiate and approve transfers of funds between the Fees Fund and the Sinking Fund.

The State Auditor, D. Arienzale, in a telephone conversation on June 2, 1976, indicated that statutory authority exists in each Public Act or Special Act for the construction, financing, and repayment of obligation bonds for each particular building that is self-supporting. His interpretation was based on conversations with the State Auditor in residence at the Comptroller's Department. The Auditor's opinion is that the Public Act or Special Act authorizing the construction and payment of self-supporting buildings contains standard clauses which require that the agency for which the building is being built is to pay for the amortization of the bonds. The establishment of the 718 Fees Fund and the 218 Sinking Fund has not been documented by the Auditors. However, these funds appear to have been established some years ago as a mechanism for the collection of fees for individual transfer to a Sinking Fund to be used for the amortization costs of the construction of self-supporting buildings at the State College level. The Auditor's opinion is that the intent of the Legislature is to be sure the agency pays for the buildings.

Section 10-116 of the General Statutes authorizes the Board of Trustees of State Colleges to fix fees for "other purposes as the Board deems necessary."

It appears from the above that statutory authority exists for the construction, amortization, and assessment of fees. Nowhere is there authority granted for you to authorize the transfer from the 718 Fees Fund to the 218 Sinking Fund, nor is there authority for an arbitrary apportionment of the amount of transfer from the collections at an individual college from the 718 Fees Fund. It would appear that you need Board authorization to effect these transfers, and I am requesting that you furnish me with a copy of a Board resolution authorizing you to make the transfers together with a formula defining the apportionment of the fees to be transferred.

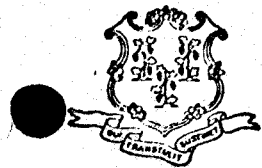



AUTHORIZING RESOLUTION

concerning

State College "Student Fee"

April 2, 1971

WHEREAS, The Legislature of the State of Connecticut has enacted Section 10, Public Act 530 in the January, 1969 Session; and

WHEREAS, Said Section 10 of Public Act 530 provides, in part, that the Board of Trustees for State Colleges, subject to the approval of the Commission for Higher Education, shall fix fees for such purposes as the Board deems necessary; and

WHEREAS, Revenue produced from the present "student fee" will not be sufficient to meet the bonded indebtedness incurred for additional facilities required by the projected student enrollments at the state colleges;

BE IT RESOLVED, That the Board of Trustees for State Colleges authorizes, effective September 1, 1971 an increase in the State College "Student Fee" from \$50 to \$75 per semester for in-state students and from \$200 to \$250 per semester for out-of-state students.

WHEREAS, The General Assembly has authorized the construction of an apartment type dormitory at Western Connecticut State College and has authorized the issuing of bonds in a total amount of \$6,540,598 to pay for said construction, and


WHEREAS, Additional funds were required in the amount of \$482,097, and

WHEREAS, The Board of Trustees, by funding the cost of equipment and art work from other sources, can guarantee sufficient funding to proceed with and complete the project, be it

RESOLVED, That, starting with State College Student Fees received during the month of October 1982, as reported by the State Comptroller, amounts specified in Board Resolution #76-74 for transfer from the State College Student Fees Fund to the State College Dormitory Sinking Fund shall instead be transferred monthly, for as long as necessary, to the account for Auxiliary Services - Central Office, the difference between the total transferred and that portion which is set aside as a reserve to meet the costs of non-recurring major repairs and renovations to be applied toward a total accumulation of \$482,097 to accomplish the purpose of this Resolution; thereafter, State College Student Fees to be deposited and distributed in accordance with the provisions of Board Resolutions #76-74 and #77-70, as amended, and be it

RESOLVED, That the aforementioned sum of \$482,097 shall be used to supplement authorized bonding in financing the budgeted costs of providing a new dormitory facility at Western Connecticut State College, particularly the budgeted costs of equipment and art work.
