This is to request that the position of Director of Institutional Safety at Eastern Connecticut State College be established by the Board of Trustees. This position, which would be an unclassified position, similar to that of Director of Public Safety at Central Connecticut State College, and superseding the present position of Chief of Security, would require a search for a man or woman who has had training and experience in campus security work, criminology and criminalistics, forensics, jurisprudence, law enforcement, riot control, and police science particularly as it relates to campus situations. The person selected should be capable of setting up and carrying out a training program for campus security officers to improve their technical and human relations skills, to maximize their effectiveness, and to make greatest possible use of state and municipal training facilities.

The position would be in the Administrator III category with salary range of Pay Group 24 (\$15,420-\$18,966) to Pay Group 29 (\$19,095-\$23,595).
