ESTABLISHMENT OF THREE SCHOOLS a.t. SOUTHERN CONNECTICUT STATE COLLEGE

March 4, 1977

After consultation with the appropriate faculty agencies, WHEREAS, the President of Southern Connecticut State College has requested that the name of the basic academic divisions of the College be changed to schools, therefore, be it

That the three academic divisions be reconstituted as RESOLVED, schools with the following designations:

> School of Arts and Sciences School of Professional Studies School of Graduate Studies, and be it further

That there be no change in the functions or salaries of the RESOLVED, Deans who serve as chief administrators of the respective schools.

BOARD OF TRUSTEES FOR THE STATE COLLEGES

Dear Jim:

Now that Central and Western Connecticut State Colleges have organized their instructional departments and divisions into schools presided over by administrators with the rank of Dean, it seems appropriate that we at Southern consider a similar organization.

Accordingly, with the support of the Cabinet, I have discussed changing the titles of our basic academic divisions to schools with the Executive Committee of the Faculty Senate which, in turn, has taken the proposal to the full membership of the Senate; at a recent meeting the Senate endorsed the proposal.

Shortly thereafter, our academic deans discussed the proposal with academic chairmen and, in turn, many of them discussed it with their faculty. No opposition has emerged from any faculty group.

At present, we have three major academic divisions: Division of Arts and Sciences, Division of Professional Studies, and Division of Graduate Studies; the administrative head of each division is a Dean. Our proposal is simply that the names of these divisions be changed, respectively, to School of Arts and Sciences, School of Professional Studies, and School of Graduate Studies; there would be no change in the assignment or functions of our academic deans nor any change in their salaries as a consequence of the implementation of this proposal. As can be seen from the attached organizational chart, this change has no significant functional impact upon the administration of the college.

I would appreciate having this proposal brought before the Planning Committee of the Board of Trustees for its consideration.
