April 1, 1977

WHEREAS, At the request of the Board, as expressed in Resolution 77-12, dated February 4, 1977, the Commission for Higher Education has already approved the the following fees for room and board, be it

RESOLVED, Fees for room and board are hereby established effective at the beginning of the fall semester in 1977:

Room Rental

Single \$650 per academic year
Double 600 per academic year
Triple 575 per academic year
Quadruple 550 per academic year
Apartment 800 per academic year


