RESOLUTION

concerning

ON-SITE SURPLUS REAL PROPERTY
for
EASTERN CONNECTICUT STATE COLLEGE

December 2, 1977

WHEREAS,

Certain real property owned by the United States, located in the County of Windham, State of Connecticut, has been declared surplus and is subject to assignment for disposal for educational or public health purposes by the Secretary of Health, Educational, and Welfare, under the provisions of Section 203 (k) (l) of the Federal Property and Administrative Services Act of 1949 (63 Stat. 377), as amended, and rules and regulations promulgated pursuant thereto, more particularly described as follows:

the former United States Post Office Building on the corner of Main and High Streets in the City of Willimantic, Connecticut.

The property consists of a single-story masonry building containing approximately 12,000 square feet of floor space, including basement area, and is located on 15,310 square feet of land at the intersection of above streets.

WHEREAS,

Eastern Connecticut State College, needs and will utilize said property for educational purposes as set forth in its application and in accordance with the requirements of said Act and the rules and regulations promulgated thereunder, of which this Board is fully informed;

NOW, THEREFORE, BE IT RESOLVED, That Eastern Connecticut State College, shall make application to the Secretary of Health, Education, and Welfare, for and secure the transfer to it of the above-mentioned property for said use upon and subject to such exceptions, reservations, terms, covenants, agreements, conditions, and restrictions as the Secretary of Health, Education, and Welfare, or his authorized representative may require in connection with the disposal of said property under said Act and the rules and regulations issued pursuant thereto; and

BE IT FURTHER RESOLVED, That Eastern Connecticut State College, has legal authority, is willing and is in a position to assume immediate care and maintenance of the property, and that Charles R. Webb, President, be and he is hereby authorized, for and on behalf of Eastern Connecticut State College, to do and perform any and all acts and things which may be necessary to carry out the foregoing resolution, including the preparing, making, and filing of plans, applications, reports, and other documents, the execution, acceptance, delivery, and recordation of agreements, deeds, and other instruments pertaining to the transfer of said property, including the filing of copies of the application and conveyance documents in the records of the Board, and the payment of any and all sums necessary on account of the purchase price thereof or fees or costs incurred in connection with the transfer of said property for surveys, title searches, appraisals, recordation of instruments, or escrow costs.



feet of floor space, including basement area, and is located on 15,310 square feet of land at the intersection of Main and High Streets, City of Willimantic, Connecticut.

Beginning at an iron pin at the intersection of the east line of High Street and the north line of Main Street, the line runs south 63° 40' east on Main Street 100 feet to an iron pin. Then north 24° 15' east 153.5 feet to an iron pin. Then north 63° 54' west 100 feet to an iron pin in the east line of High Street. Then south along High Street 24° 15' west 153.1 feet to the beginning.

- 3. A right of way for the grantee exists on a strip of land 15 feet wide running parallel with and abutting on the east and north boundary lines of said premises and extending from Main Street to High Street.

IV. Proposed Program of Use

A. At the present time the College plant is overcrowded.

If the Post Office property should be acquired, it will be used primarily as a support area for the Plant and Maintenance Department activities of Eastern Connecticut State College for the storage of:

Furniture - excess, old and new, particularly from apartments waiting for delivery to and from repair from the State Prison

Teaching aids, old and temporarily surplus desks, chairs, chalk boards

Maintenance and housekeeping supplies:

In addition, the Nathan Hale residential hall on Main Street in Willimantic is in close proximity to the Post Office property and has no parking for the staff and students housed in the hall. The 31 parking places at the Post Office Building will be used by persons from the Nathan Hale residential hall.

When the weather is such that heating of the building is not required for use, the front walk-through area will be used for such community activities as our summer arts/crafts exhibit.

The above uses will require no major improvements to the property.

At its regular meeting February 4, 1977, the Board of Trustees passed the Mission Statement for the State Colleges.

The full text follows as does the Mission Statement for Eastern Connecticut State College which was approved last year but had not yet been distributed.

INTRODUCTION

The Connecticut State Colleges exist to provide low cost, high quality and conveniently accessible higher education opportunities to Connecticut citizens.

Each of the four Colleges functions as a regionally-oriented institution, serving the advancement of its region through quality academic offerings, public service projects, continuing education and cooperative community programs, and as an integral segment of the Connecticut State College system, united in common admissions, transfer and cross-registration programming; joint academic planning and physical resources utilization.

I. Fundamental Goals of the System

Each College meets, but is not limited to the following specific goals:

- 1. To serve students at both undergraduate and graduate levels.
- 2. To prepare students both to lead and to function effectively in a rapidly changing society.
- 3. To provide a campus climate (physical, social, philosophical, and intellectual) conducive to learning and to the development of human values and social responsibility.
- 4. To provide the academic community with the optimum resources available for teaching, experimentation, and research appropriate to the institution and the needs of the people of Connecticut.
- 5. To provide leadership and service to public education, governmental agencies, business, and industry, both regionally and state-wide.

- 6. To cooperate in community endeavors for the public good, within the limitations of institutional resources and purposes.
- 7. To cooperate in academic consortia with other institutions of higher education.

II. General Academic Offerings

The curricula of the Colleges have evolved as a result of two major developments:

- 1. Legislative direction for the State Colleges to provide teacher education programs at the undergraduate and graduate levels necessary to support the public education needs of the State, and
- 2. Response to demonstrated and justified needs in such areas as the liberal arts and vocational fields such as nursing, business administration, industrial and medical technology.

At present, and in the immediate future, basic degree programs will be on the Bachelor's Degree level in education, technological studies, professional studies, business education, and the liberal arts. In a concerted effort to meet the educational needs of the State, and especially those of the geographic regions in which each College is located, the Connecticut State Colleges are also authorized to offer the Associate Degree and Master's Degree in the liberal arts, education, and in certain professional and career fields; and Sixth-Year Professional Certificates in certain specialities. The Associate Degree programs are offered on a limited basis under an agreement with the Regional Community Colleges to serve students in geographic areas not conveniently served by the public two-year colleges.

Teacher education will continue a prominent academic function of the four Colleges. However, the significance of the liberal arts, professional studies, and career programs will increase. Citizen demands upon the Colleges reveal an increasing need that graduate programs in career-related fields be made available on a regional basis. Response to such demands is a part of the mission of each College. Along with demand for regional graduate programs in career fields has come a demonstrated need for supplementary forms of instructional programming, including off-campus, on-site service programs; cooperative college-industry programs; alternate teacher accreditation systems and alternate learning programs.

III. The Changing and Emerging Role of the Four Colleges

An analysis of past progress, present resources, and current national trends reveals an emerging role for the Connecticut State Colleges characterized by dramatically changing educational needs. The new role is defined as the system's responses to four major forces:

- 1. The impact of new knowledge on the lives of people.
- 2. The increased necessity to solve major social problems through "education for change."
- 3. The impact of rising costs of full-time higher education.
- 4. The energy crisis and its ecological correlates.

A. Development of New Bachelor's Degree Programs

State Colleges, which once only prepared students for a career in education while providing them with a background in the liberal arts, today must prepare students for work in a variety of fields. Hence, each College must maintain a strong liberal arts curriculum. Not only do the liberal arts themselves provide career opportunities—in such areas as communications, government, public administration, the dramatic and fine arts and the academic professions—but they also provide entry to advanced study in such professional fields as law, medicine, pharmacy, architecture and theology.

Just as the State Colleges in 1933 met the State's need for trained teachers, so now must they meet demands to provide new career-oriented Backelor Pegree programs in fields such as criminal justice, industrial technology, business administration, allied health fields, and the computer sciences

health fields, and the computer sciences.

These and other fields, formerly on the vocational-technical level, are emerging as baccalaureate-level professional specialties; requiring the resources of the State's public institutions to attain professional status. Graduates of the two-year Community Colleges and Technical Colleges are enrolling in increasing numbers in the Connecticut State Colleges to continue their education to the baccalaureate level. Well coordinated transfer programs, flexible degree requirements, jointly-planned general education and "majors" programs are being developed by all of four Colleges to meet changing needs.

B. Development of New Post-Baccalaureate Programs

New knowledge has had a tremendous impact on higher level occupations, making it necessary for many professionals to continue their education beyond the baccalaureate level. Continuing education programs on the Master's level have already been introduced at all State Colleges to permit more persons to enter such fields and to up-date professional knowledge. These offerings must be broadened and increased in all fields where demand is heavy. Existing and projected part-time education programs, in-service training programs, work-study internships, cooperative educational programs with the public schools, businesses and industries, all exemplify need for expanded part-time, post-baccalaureate, and continuing education programs.

The energy crisis and the current economic crisis will prompt many more persons to seek part-time graduate education within reasonable distance and at reasonable cost, hence the geographic locations of the four State Colleges make them especially appropriate

to offer such programs. The growing response of citizens of Connecticut to such programs is significant. In 1964, there were 3,286 students enrolled in part-time, post-baccalaureate programs. By 1976, the figure had increased to 8,741.

C. System Responses to Regional Needs

The four Connecticut State Colleges are uniquely qualified to respond to the needs of the communities in their geographic regions because of their identification with their regions and because the professionals serving each College know its regional problems and resources. Much has already been done by each college to serve its region. Much more will be done in the future. It is increasingly apparent that governmental agencies, organized interest groups, professional organizations, and individual citizens look more and more to educational institutions and their professional personnel to provide leadership in improving social, cultural, and economic conditions. The Connecticut State College System offers a pool of specialized human resources to serve such needs.

IV. Future Development

To respond to the impact of new knowledge on the lives of our people, to provide cultural opportunities, and to solve major social concerns and economic pressures of modern society a new kind of State College must evolve. It must offer programs in the liberal arts and sciences which emphasize theory, the transmission of basic knowledge and the fulfillment of intellectual capabilities as well as professional programs emphasizing practices, the acquisition of applied knowledge and the development of vocationally-oriented skills. It must be diversified - developing intellectual resources, preparing people to earn a living, and serving the public through applied research, extension programs and continuing education. In short, over the decade ahead, it must become a College comprehensive enough to meet regional needs.

Specific Regional Functions of the State College System

Each College must:

- 1. Aid the economic and social advancement of the institution's surrounding region through continuing education programs, public service programs and research.
- Maintain cooperative efforts with a region's schools; provide guidance about admission for high school graduates; develop coordinated pre-service and in-service teacher education programs.
- 3. Maintain cooperative efforts with regional business, industry, and government to develop coordinated pre-service and in-service career and professional programs.
- 4. Share faculty and other resources with the Regional Community Colleges, Technical Colleges and units of the University of Connecticut in the institution's region.

- C. A respect for an enjoyment of intellectual curiosity and creativity.
- D. An understanding and acceptance of diverse human and cultural aspirations.
- E. The ability to recognize complexity and uncertainty not only as inevitable but also as creative elements in individuals and societies.
- F. The communicative skills necessary for productive interaction in personal, professional, and social experiences.
- G. The objectivity and detachment necessary for productive problem-solving.
- H. The commitment to develop one's talents for personal satisfaction and for the enrichment of the human condition.
- I. The development of occupational skills necessary for continuing productivity in a rapidly-changing society.
- J. The maturity and insight necessary for self-realization and evaluation.
- K. The ability to recognize and the spirit to resolve social problems.
- L. A respect for and appreciation of cultural, religious and social diversity.
- M. A respect for individual uniqueness.
- 2. Maintain an admissions policy which makes the College's programs and courses of study accessible to qualified candidates:
 - A. without regard to age, sex, race, creed, national origin, or economic position.
 - B. from all accredited secondary schools, colleges, and universities.
 - C. who may offer vocational and/or professional experience as well as academic preparation as a basis for admission.
 - D. who are evaluated for admission on the basis of comprehensive criteria which include individual uniqueness as well as traditional academic preparation.
- 3. To foster within the College community an atmosphere which encourages the utilization of rationality and civility in institutional decisionmaking.
- 4. To develop adequate resources and facilities, especially library and media materials and staff, to serve as a foundation for productive programs and courses of study.

In addition to new degree programs, increased emphasis will be directed toward non-degree professional activities to meet the educational needs of the medical, scientific, business, and education communities. Formal workshops and conferences related to regional and national social-economic problems will contribute to the well-being of the community, the state, and the nation.

College programs will seek to:

1. Maintain and broaden comprehensive programs in arts and sciences fields such as:

Biological Sciences
Communication Arts
Computer Science
Connecticut Studies
Environmental Earth Science
Public Policy
Urban Studies

2. Strengthen the professional studies commitment of the College with evolving programs in fields such as:

Health Services
Criminal Justice
Economics and Administrative Science;
Management Science
Public Service
Teacher Education

- 3. Continue and develop alternate programs such as credit by examination, the three-year degree, external degrees, credit for learning by life experience, and the S.W.E.A.T. (Student Work Experience and Applied Theory) program.
- 4. Provide opportunities for continuing programs for lifelong development of intellectual, recreational, and vocational/technical abilities.
- 5. Work with the community colleges and vocational/technical colleges to provide baccalaureate degree-programs; develop similar programs with other four-year institutions, both public and private.
- 6. Utilize the College as a social problem-solving institution.
- 7. Provide programs to meet the needs of the region, state, and nation as the rapid increase in technology requires.
- 8. Continue and expand work-study internships and cooperative education programs to complement the student's formal academic preparation.
- 9. Expand in-service degree and non-degree programs for the professional (scientific, business, and educational) community.


- 10. Support and nurture research and creative activities among its students and professional staff.
- 11. Make greater use of such instructional aids and techniques as computer-assisted instruction; broadcast, cable, and closed-circuit television; and individualized instruction.
- 12. Implement graduate programs in those academic disciplines where institutional strength dictates.
- 13. Strengthen existing and implement appropriate associate degree programs.
- 14. Upgrade the College's computer facilities so that they may more fully be utilized in the teaching of computer-oriented problem solutions and the application of prepared programs.
- 15. Maintain and expand the College's nationally-recognized arts and crafts programs.
- 16. Elaborate cooperative programs with the Windham Regional Vocational High School.

PHYSICAL FACILITIES

There must be a continuing review of land, plant, and facilities to effect maximum utilization.

The prime institutional needs are expanded student housing; health service facilities,; classrooms and laboratories on the North Campus; appropriate facilities for the fine and performing arts, the natural sciences, and professional studies; student recreational areas and facilities; and adequate parking space. Most important of these is the development of student housing facilities. The College's rural location and the absence of sufficient community resources place a premium on campus-based living facilities. Admission and attrition figures indicate a loss of qualified students due to the College's inability to house them.

The College's physical expansion on land not adjacent to the original campus has resulted in a College operation separated into three localities. Such separation has effected institutional diffusion and has proven to be inefficient from the standpoint of plant maintenance. It is thus imperative that the College in the future consolidate its facilities into one campus.

- 5. Much of the storage square footage is in the basement--there is no evidence of flooding.
- 6. The parking spaces afforded by the property are valuable enough to warrant acquisition of the property even if the building itself should prove unusable.
- 7. We are now at the application, not acceptance, stage.

The approximately 25 parking spaces will be used for staff and students housed at the Nathan Hale Residence Hall.

Since there will be no need for heat, water or electricity for the above areas, the cost of operation will be the time spent by the Building and Grounds staff in custodial duties to maintain the property.

U. S. Post Office for Physical Plant Use

The U. S. Post Office at the corner of Main and High Streets contains about 9,660 square feet of usable floor space; about 4,860 square feet on the main level and about 4,800 in the basement. There are approximately 31 available parking spaces.

Cost of cleaning the building prior to storage would require the work of two men for about two weeks which would be a cost of about \$650.00.

Annual cost of snow removal would be about \$500.00. The work of snow removal would be done by ECSC personnel. Annual cost of grass cutting, shrub maintenance, etc. would also be about \$500.00 which would be done by ECSC personnel. Maintenance to the building itself would be minimal. Painting of the outside sash would be necessary at an approximate cost of \$300.00.

If electricity is provided to the building, the minimum monthly charge would be \$4.35, and the maximum monthly charge would be \$15.00. The only use of electricity would be for lights.

Attached is a list of materials and equipment that would be moved to the Post Office and the buildings from which these materials would be moved. Included in the list is the approximate square feet of space that will be freed for other purposes.

It should be pointed out that several mechanical spaces have flammable materials stored in them and this constitutes a definite fire hazard. Also, the overhead storage in the Nathan Hale Garage has already been noted by OSHA in a courtesy inspection although no citation was issued.

Health or Educational Usc. Section 203(k) (1) of the Federal Property and Administrative Services Act of 1949, as amended (40 U.S.C. 484(k) (1)), authorizes the Administrator of General Services, in his discretion, to assign to the Secretary of Health, Education, and Welfare for disposal such surplus real property, including buildings, fixtures, and equipment situated thereon, as is recommended by the Secretary of Health, Education, and Welfare as being needed for school, classroom, or other educational uses, or for use in the protection of public health, including research. The Act authorizes the Secretary to sell or lease such properties to States or their political subdivisions and instrumentalities, and tax-supported medical and educational institutions, non-profit educational institutions, hospitals, or other similar institutions not operated for profit which have been held exempt from taxation under section 501(c)(3) of the Internal Revenue Code of 1954, and to fix the sale or lease value of the property to be disposed of taking into consideration any benefit which has accrued or may accrue to the United States from the use of the property by any such State, political subdivision, instrumentality, or institution. The principal restrictive provision in the instrument of conveyance requires the property to be used continously for a specified period for the specific purpose stated in the application for the property made to the Department of Health, Education, and Welfare.

THE FEDERAL PROPERTY ASSISTANCE PROGRAM

The FPA Program is a grant-in-aid program providing support to public health and educational communities. Grants are awarded in the form of federal surplus properties to organizations which meet eligibility and program requirements, and can demonstrate the means to implement the prospective programs. To be eligible, organizations must be either public bodies or non-profit institutions which are tax exempt under Section 501 (c) (3) of the Internal Revenue Code of 1954. The intended program of usage must be for health or educationally-oriented purposes.

Properties are made available to the Department by the General Services Administration after they have been determined to be surplus to the needs of the Federal Government. HEW's Federal Property Assistance Program then attempts to screen as many organizations as possible which may have a potential interest in the property and alert them as to its availability. Although HEW does not maintain an inventory of federal surplus property, in many instances we may have the means to determine whether properties previously identified as surplus can still be made available.

All properties are conveyed at the fair market value less a public benefit allowance (discount) when surplus real property is granted for worthwhile health or educational programs. Properties are usually granted at a 100% discount.

The instrument which effects the conveyance is a Deed Without Warranty which usually contains four conditions. It is important to note that the conditions restrict the use of the property to the health or educational programs set forth in the application for a period of thirty years. Other usages during this period must be authorized in writing by the Department. Free and clear title to the property will pass to the grantee after the period of restrictions has expired.

Properties granted through the Federal Property Assistance Program are conveyed in an "as is" condition. Therefore the cost and extent of renovations should be considered by applicants in evaluating the suitability of available property for their own programs.

The net result of our program is that many organizations and institutions, not otherwise having all of the resources necessary, may be able to implement, improve or expand beneficial programs within their own communities.

DEED CONDITIONS

If all or any part of the subject properly is conveyed to your institution, the conveyance instrument will be a Deed Without Warranty which will contain the following conditions subsequent:

- 1. That for a period of thirty (30) years from the date of the Deed, the property conveyed shall be utilized continuously in the manner and for the educational purposes set forth in the approved program and plan contained in the Transferee's application and for no other purpose;
- 2. That during the aforesaid period of thirty (30) years, the Transferee will resell, lease, mortgage, or encumber, or otherwise dispose of the property or any part thereof or interest therein only as the Department of Health, Education, and Welfare or its successor in function in accordance with existing regulations, may authorize in writing;
- 3. That one year from the date of the Deed and annually thereafter for the aforesaid period of thirty (30) years unless the Department of Health, Education, and Welfare or its successor in function otherwise directs, the Transferee will file with the Department of Health, Education, and Welfare or its successor in function reports on the operation and maintenance of the property and will furnish, as requested, such other partinent data evidencing continuous use of the property for the purpose specified in the application.
- That for the period during which the property is used for a nurnose for which the Federal financial assistance is extended by the Department or for another purpose involving that provision of similar services or benefits, the Transferse hereby agrees that it will comply with Title VI of the Civil Right: Act of 1964 (P.L. 89-352) and all requirements imposed by or pursuant to the Regulations of the Department of Health, Education, and Welfare (45 CFR Part 90) issued pursuant to that title and as in effect on the date of this deed, to the end that, in accordance with Title VI of that Act and the Resulation, no person in the United States shall, on the ground of race, color, or national origin, be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination under the program and plan referred to in condition I above or under any other program or activity of the Transferee, its successors or assims, to which such Act and Regulation apply by reason of this conveyance.

In reply to letter written Donald Branum:

Mr. Wieczorek said that HEW would be returning the Post Office building to GSA by noon, July 18, 1977, and that GSA has 30 days to screen Federal agencies that might be interested in the building. If there are none, then HEW will offer the building again for educational and health purposes use.

He made it very clear two or three times that storage for an educational institution is a legitimate purpose and that an award of a Federal building is similar to a land grant for a period of 30 years. There are restrictions for 30 years; after that, the building becomes the property of the owner.

He will be sending an information package. He also mentioned that the Federal government is not responsible for any charges for executing the 30-year deed.

He also mentioned he had a letter from Earl McSweeney the day after he received Mrs. Wilson's. Mr. McSweeney also indicated interest in having the Court secure the building for their use, if possible.
