DEAN OF PERSONNEL ADMINISTRATION
at
CENTRAL CONNECTICUT STATE COLLEGE

January 6, 1978

- WHEREAS, The requirements of contract administration and the growing complexities of personnel relationships call for adjustments in the organization of the management structure, and
- WHEREAS, The Board of Trustees for the Connecticut State Colleges has created the position, Dean of Personnel Administration, on each campus, and
- WHEREAS, Central Connecticut State College, in accordance with the requirements of affirmative action, has set up a search committee which has made a unanimous recommendation to the College President who in turn has strongly endorsed that recommendation and transmitted it to the Board of Trustees, and
- WHEREAS, The Personnel and Employee Relations Committee has carefully examined the credentials of and, through the Chairman of that Committee and the Chairman of the Board of Trustees for the State Colleges, interviewed the candidate recommended by the Presdient of Central Connecticut State College; therefore, be it,
- RESOLVED, That under the authority granted in Section 14 of Public Act 77-573, Dr. Michael Becker is hereby appointed Dean of Personnel Administration at Central Connecticut State College, effective January 6, 1978, at an annual salary of \$24,500.

EMPLOYMENT HISTORY AND EXPERIENCE

9/67 - Present: CENTRAL CONNECTICUT STATE COLLEGE 10/75 - Present: CONNECTICUT STATE COLLEGE - AAUP*

Appointed as an instructor in 1967, promoted to Assistant Professor and granted tenure in 1970, and promoted to Associate Professor in 1977. Primary teaching area is Renaissance and Reformation Europe. Have also taught introductory Economics. In three of last five years, including two most recent, have been evaluated as a superior teacher by department chairman. Because of interest in advising students and unravelling complex institutional regulations, have been assigned responsibility for advising part-time matriculant and transfer students in History. Served five years in policy making faculty senate (one year as its Secretary), one year on college-wide curriculum committee, on all but the promotion and tenure committee of History department, and currently on college-wide Graduate Committee. Also served as faculty advisor to Academic Planning Committee for State Colleges of Connecticut for two years.

*Was elected Treasurer of CSC-AAUP at its creation in October 1975 and continue in that office as effective second in command of the union. With President, planned and directed campaign against AFT to be elected bargaining agent for the 1220 faculty in the Connecticut State Colleges. Camapign was successful and certification was granted in May 1976. With victory came responsibility for establishing and managing an annual budget of \$165,000 and full-time paid staff of three. Because of previous contract writing experience (See Navy Job Below) was given primary responsibility for developing contract proposals to present to Board of Trustees. During the negotiating process, had the job of coaching the bargaining team on the CSC-AAUP proposals and negotiating strategy. In that capacity had duty of attending all bargaining sessions and of directly negotiating several issues. Currently serve as union contract administrator and grievance officer for CCSC campus. The office is without compensation.

Hired as GS-7 trainee negotiator of supply contracts, promoted to GS-9 after one year. Was responsible for negotiating supply contracts for San Francisco Bay naval installations.
