WHEREAS, After consultation with President Bersi, Dr. Frost has recommended that Dr. Carl L. Robinson, Vice President for Administrative Affairs at Western Connecticut State College, be appointed Acting Executive Officer for Finance and Management while retaining his title and office at Western Connecticut State College; therefore, be it

RESOLVED, That Dr. Carl L. Robinson be and hereby is appointed Acting Executive Officer for Finance and Management to serve until such time as Mr. Rossomando returns to take up his duties, and be it

RESOLVED, That during his tenure as Acting Executive Officer for Finance and Management, Dr. Robinson shall retain his title and authority as Vice President for Administration at Western Connecticut State College, and that Western Connecticut State College shall remain his duty station, and be it

RESOLVED, That during his tenure as Acting Executive Officer for Finance and Management Dr. Robinson's salary of \$34,551 be increased on an annual basis by \$4,000, and be it

RESOLVED, That the President of Central Connecticut State College is requested to provide Dr. Robinson a guest room in the College Residences for his use without charge during Dr. Robinson's tenure as Acting Executive Officer for Finance and Management.


