

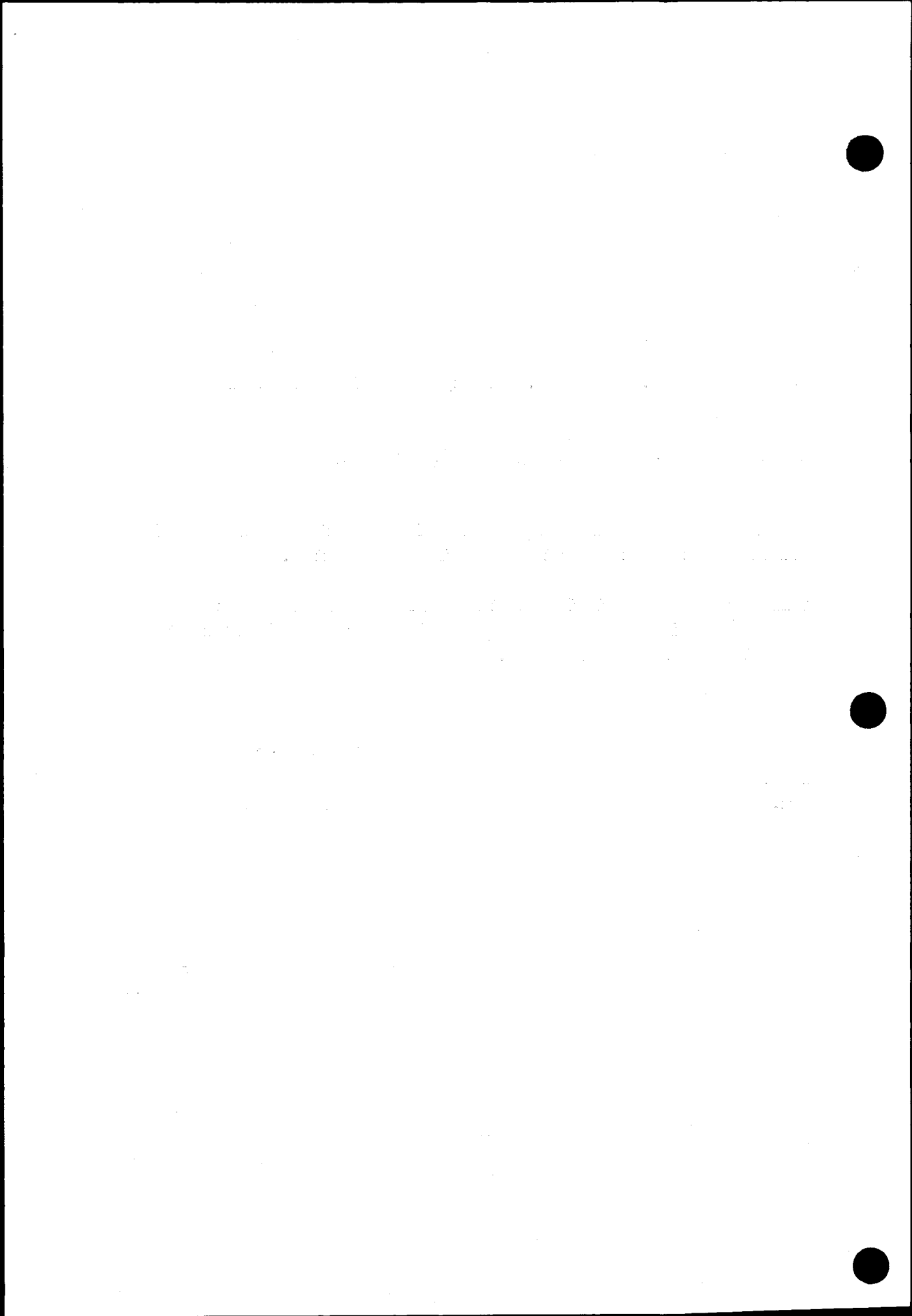
Would you please place the enclosed resolution on the agenda for the next meeting of the Planning Committee.
