AUTHORIZATION FOR CENTRAL CONNECTICUT STATE COLLEGE TO PERFORM REPAIRS IN BUILDINGS SUPPORTED BY THE AUXILIARY SERVICES FUND TO ELIMINATE FIRE AND SAFETY HAZARDS

February 2, 1979
