concerning

EDUCATIONAL EXTENSION FUND and AUXILIARY SERVICES FUND

February 2, 1979

WHEREAS, The Comptroller of the State of Connecticut has for reasons of accounting efficiency consolidated the individual State College Revolving Funds into two single coded funds, e.g., fund code 6111--State College Educational Extension Fund and fund code 6900--State College Auxiliary Services Fund, and

WHEREAS, It is the policy of the Board of Trustees for the State Colleges that each of the four State Colleges operate within the resources of their Educational Extension Fund and of their Auxiliary Services Fund, therefore, be it

RESOLVED, That each of the four State Colleges shall maintain practices, records and procedures which will enable them to limit the expenditures of either their Educational Extension Fund or Auxiliary Services Fund to the resources developed in said funds, and be it further

RESOLVED, That should the need arise to shift the resources of either fund from one college to another, the presidents of the involved college shall so request of the Executive Director who may approve or disapprove such transfers provided the amount involved in any single transaction does not exceed \$25,000 and provided any such transfer is reported to the Trustees' Budget Committee.
