Student Referendum

I approve of the Student Government of Western Connecticut State College raising the student fee to \$36.50 per student. This student fee increase will take effect immediately and will be collected in the following manner: Fall Term = \$19.00

Spring Term = \$17.50

Total = \$36.50

Presently, the Student Government of fee is \$24.50 per student. The Student Government supports raising the fee to \$36.50 because of the fiscal reality that we are now spending \$31.50 per student. The student fee of \$36.50 that we support is a 15 percent increase over current expenditures of \$31.50 for 1978-1979. This fee was agreed upon because of increased student services and a 10 percent inflation rate.


