

- WHEREAS, Mrs. Lang created the School and Community program and has, since 1973, been the architect of the Social Work program at Southern Connecticut State College, and
- WHEREAS, Mrs. Lang has been a stimulating colleague to her fellow faculty members and an inspiration to her students, now, therefore, be it
- RESOLVED, That the Trustees express their deep appreciation to Mrs. Lang for her years of expert leadership and excellent teaching, and that they wish her well in her retirement, and be it further
- RESOLVED, That effective upon the day of Professor Lang's retirement the house located at 93 Farnham Avenue, New Haven, Connecticut shall be named the Pauline R. Lang Social Work Center.

Dear Jim:

With Mrs. Pauline Lang, Director of the Social Work Division, retiring at the end of the summer, a representative of the Division faculty has asked if it is possible to name the house in which the Division has its offices after Mrs. Lang. I am assured that such an action by the Board of Trustees would be well received by the faculty.

I have also discussed the matter with my Cabinet and they are unanimously in support of naming the house after Pauline. Accordingly, I ask that the house be named: Pauline R. Lang Social Work Center.

I enclose a copy of her resume. You can derive from that document some clues to the extensive community service work she has contributed in the greater New Haven area, particularly in the years before she came to Southern Connecticut State College. You will note also how frequently over the years she has travelled out of state to professional meetings--virtually all of them at personal expense. She created the School and Community Program at Southern, a program in which all professional studies students had some experience in a social or other type of agency--a program considered highly successful, but now somewhat curtailed because of the shortage of funds and personnel. And since 1973 she has been the architect of our social work program, with which you are quite familiar.

I have absolutely no reservations in making this recommendation and trust that it can be placed on the agenda of the Planning Committee for its next meeting.

Dear Dr. Frost:

Thank you for your warm letter and the enclosed Resolution expressing the appreciation on the part of the Trustees for my services at Southern, to my community, and to the State Colleges. Within the last few weeks I have received many honors, but none which has touched me so deeply as the honor you have bestowed on me by naming the Social Work House the "Pauline R. Lang Social Work Center." The part which is most gratifying to me is calling the total program a "Center," which is getting closer to calling the program a School.

As you know, most of the M.S.W. programs are called Schools of Social Work, and I pray that in the near future the Connecticut State Colleges will become State Universities (autonomous) as they are in states such as Illinois.
