WHEREAS, Section 10-116 of the General Statutes provides that the Board of Trustees for State Colleges, subject to the approval of the Board of Higher Education, shall fix fees for such purposes as the Trustees deem necessary, and

WHEREAS, The Student Senate of Central Connecticut State College on October 7, 1980 passed Motion SS-91-80, as amended by Motion SS-116-80 on November 25, 1980, calling for an increase of \$6.37 per semester in the Student Activity Fee for a total of \$21.78 per semester, be it

RESOLVED. That, if the Board of Higher Education concurs, a Student Activity Fee of \$21.78 per semester is established for Central Connecticut State College, effective for the Fall Semester 1981.
