

### INCREASE IN COLLEGE GENERAL FEE

February 6, 1981

- WHEREAS, Section 10-116 of the General Statutes provides that the Board of Trustees for State Colleges, subject to the approval of the Board of Higher Education, shall fix fees for such purposes as the Board of Trustees deems necessary, and
- WHEREAS, Revenue produced at current rates is not sufficient to cover escalating costs due to inflation, increased rates for fuel and utilities, and salary adjustments, be it
- RESOLVED, That Board Resolutions #79-146 and #80-21 are hereby rescinded, and be it
- RESOLVED, That, if the Board of Higher Education concurs, the State College General Fee, effective for the Fall Semester 1981, shall be changed as follows:
