### RESOLUTION

Concerning

AUTHORIZATION TO PERFORM REPAIRS IN BUILDINGS  
SUPPORTED BY THE AUXILIARY SERVICES FUND



June 12, 1981

- WHEREAS, The Board of Trustees authorized the establishment of a Central Office Auxiliary Services Account (6900) to meet the cost of non-recurring major repairs to student residences, food service areas, and student centers, and
- WHEREAS, The Board of Trustees by Resolution #79-52 authorized the expenditure from said account of \$48,000 for the purpose of installing an elevator for the handicapped at Memorial Hall at Central Connecticut State College and of \$75,000 to renovate bathrooms in Burr Hall at Eastern Connecticut State College; and by Resolution #80-51 authorized the expenditure of \$49,500 to install a new roof on said Burr Hall, all of which amounts are exceeded by current cost estimates, and
- WHEREAS, The General Assembly, through Special Act #81-31, effective May 21, 1981, has acted on a request by the Board of Trustees, in accordance with the provisions of Section 10-114 of the General Statutes, to authorize expenditures for the aforesaid projects in amounts not to exceed current estimates, be it
- RESOLVED, That expenditures for the following projects, to be funded from the Central Office Auxiliary Services Account and in amounts not to exceed those stated, are hereby authorized:
- At Central Connecticut State College, Memorial Hall -
    - Installation of an elevator for the handicapped -
      - Increase from \$48,000 to \$155,000
  - At Eastern Connecticut State College, Burr Hall -
    - Renovation of Bathrooms - Increase from \$75,000 to \$130,000
    - Re-roofing - Increase from \$49,500 to \$ 85,000

Substitute Senate Bill No. 1289

SPECIAL ACT NO. 81-31

AN ACT AUTHORIZING RENOVATIONS AND REPAIRS AT THE STATE COLLEGES.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

Section 1. The board of trustees of the state colleges is authorized to expend: (1) An amount not exceeding three hundred twenty-five thousand dollars for the complete renovation of the fire alarm systems in auxiliary services buildings at Western Connecticut State College; (2) an amount not exceeding one hundred thirty thousand dollars for renovation of bathrooms in Burr Hall at Eastern Connecticut State college; (3) an amount not exceeding eighty-five thousand dollars for roofing at said Burr Hall; (4) an amount not exceeding one hundred twenty-five thousand dollars for rehabilitation and weatherproofing of exterior walls of the College Union at Southern Connecticut State College; and (5) an amount not exceeding one hundred fifty-five thousand dollars for an elevator for handicapped persons at Central Connecticut State College.

Sec. 2. The amounts expended under section 1 of this act shall be paid from the state college auxiliary services fund established and administered under section 10-114 of the general statutes.
