
General Duties and Responsibilities

The Executive Dean for Campus Affairs is directly responsible to the President of Southern Connecticut State College for all matters related to physical plant, campus engineering and architecture, student affairs, security, and intercollegiate athletics. As such, the Executive Dean for Campus Affairs is the chief operating officer of the campus and is a senior administrative officer reporting to the President.

Specific Duties and Responsibilities

- 1. Responsible for all maintenance, custodial and grounds services.
- Responsible for all aspects of security related to persons and property.
- 3. Responsible for all aspects of student services and student affairs including all facilities and functions attendant thereon.
- 4. Responsible for all aspects of intercollegiate athletics including legislative compliance, community relations, fiscal integrity, quality control, and academic standing.
- Responsible for all aspects of campus engineering campus architecture, and related functions.
