RESOLUTION

concerning

A CONTRACT FOR THE AUDITING OF FEDERALLY SUPPORTED STUDENT
FINANCIAL AID PROGRAMS OF
CENTRAL CONNECTICUT STATE COLLEGE
AND
EASTERN CONNECTICUT STATE COLLEGE

March 5, 1982

WHEREAS, The United States Department of Education requires that Federally supported student financial aid programs be audited by independent auditors at least once every two years, and

WHEREAS, In June 1980 the Board of Trustees for State Colleges contracted with the accounting firm of Peat, Marwick, Mitchell & Co. to audit the aforesaid financial aid programs for specified periods between July 1, 1976 and June 30, 1980, and said firm now is thoroughly familiar with the pertinent operations, locations, and staff of the colleges and the Central Office of the Connecticut State College System, be it

RESOLVED, That the accounting firm of Peat, Marwick, Mitchell & Co. shall be appointed to perform an audit of the National Direct Student Loan, College Work-Study, Supplemental Educational Opportunity Grant, and Pell Grant (formerly the Basic Educational Opportunity Grant) Programs of Central Connecticut State College and Eastern Connecticut State College for the fiscal years ended and ending June 30, 1981 and 1982, and be it

RESOLVED, That the Executive Director of the Connecticut State Colleges is authorized to negotiate the terms of the contract with Peat, Marwick, Mitchell & Co. covering the appointment and in an amount not to exceed \$18,700, and that the Executive Director or the Executive Officer for Finance and Management is authorized to sign such a contract.

DEVELOPMENT OF A COMPUTERIZED DATA PROCESSING SYSTEM FOR THE CONNECTICUT STATE UNIVERSITY

October 7, 1983

WHEREAS, In compliance with the provisions of Board Resolution #82-55,

compatible data processing equipment for administrative purposes is now in place throughout the Connecticut State University

system, and

WHEREAS, The Board of Trustees desires that activity be continued to attain

the goals set forth in the July 15, 1982 Five-year Plan for

Administrative Data Processing Equipment and Software, and

WHEREAS, In the interest of efficiency and cost effectiveness, centralized

policy administration is needed for the development of uniform

administrative data processing systems; be it

RESOLVED, That the process of developing, for administrative purposes, a comprehensive computerized data processing system for the

Connecticut State University shall continue in order to attain the goals set forth in the July 15, 1982 Five-year Plan for

Administrative Data Processing Equipment and Software, attached as

an addendum to this resolution, and be it

RESOLVED, That there shall be established in the Central Office of the

Connecticut State University data processing staff with full responsibility for the administration of University-wide computerized data processing systems and for the acquisition and/or development of such programs as may meet the administrative

needs of the University.
