

She was a sophomore at Southern Connecticut State College, majoring in special education. She was captain of the track team and a member of the varsity basketball team. 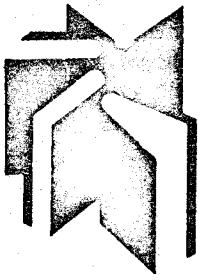
