SUBJECT: RIGHT OF WAY FOR DRAINAGE EASEMENT - SOUTHERN CONN. STATE COLLEGE

We will need a resolution from your Board and the Board of Higher Education concerning the above-mentioned easement.

I suggest the resolution be worded as follows:

RESOLVED that the Board of Trustees for State Colleges does hereby authorize and request the Commissioner of the Department of Administrative Services to contract for an agreement with the Town of Hamden for the granting of an easement on the campus of the Southern Connecticut State College to the Town of Hamden for storm sewage purposes.

I am currently drafting an agreement between the State of Connecticut, acting through the Commissioner of the Department of Administrative Services, and the Town of Hamden, for the granting of the easement.

I will send a copy of the agreement to the Mayor of Hamden for his signature. We will need a resolution from the Town Council authorizing the Mayor to sign the agreement.

After receiving back the executed agreement, we will send it to the State Treasurer's office for execution and delivery of the instrument granting the drainage casement to the Town.

According to Section 4-26 of the General Statutes, as amended, the agreement must be signed by both parties and approved by the Attorney General while the General Assembly is not in session.

I hope we will have the necessary resolutions and documents in order by then, so that they may be signed promptly and forwarded to the Treasurer's office.



EASEMENT

KNOW ALL MEN BY THESE PRESENTS: That We/I,

County of and State of Connecticut hereinafter referred to as "grantors", for and in consideration of the sum of ONE DOLLAR and other valuable considerations, the receipt of which is hereby acknowledged, do hereby give, grant, bargain and sell, and by these presents do bargain, sell, convey, transfer and deliver unto the Town of Hamden, a municipal corporation organized and existing under the laws of the State of Connecticut, hereinafter referred to as "grantee", a permanent and perpetual easement and right-of-way over, through, under and across, including the perpetual right to enter upon, all of the land hereinafter described, at any time that said grantee may see fit, for the purpose of cleaning, trenching for, laying, constructing, maintaining sewer system for said Town of Hamden, toand repairing a storm gether with the right to survey, excavate and refill ditches and/or trenches for the location of said storm sewer system and the further right to remove trees, bushes, undergrowth and other obstructions interfering with the location, construction and maintenance of sewer system and the further right and easement to do said storm every other act and thing necessary or desirable incidental to the clearing, trenching for, laying, constructing, maintaining and repairing said storm sewer system.

The land affected by the grant of this easement and rightof-way is located in the Town of Hamden and State of Connecticut and is more particularly described as follows:

On two maps attached and labeled Maps #1 and #2, "Permanent Easement -Drainage Relief through Property of State of Connecticut, No. 4 Prescott Street, Scale 1"=40', Date: February 1982".

To have and to hold said easement and right-of-way unto said grantee, and unto its successors and assigns forever, for the uses and purposes herein set forth.

The grantor does hereby covenant with said grantee that they are lawfully seized and possessed of the real estate above described, and they have a good and lawful right to convey it, or any part thereof, that it is free from all encumbrances, that they

will forever warrant and defend the title thereto against the claims of all persons whomsoever.

Said grantor(s), their heirs, successors and assigns hereby covenant with said grantee that said grantee's officers, representatives, agents, servants and employees may, at any time and at all times, when necessary or convenient to do so, go over, under, through, across and upon said described premises, to do and perform any and all acts necessary or convenient in carrying into effect the purposes for which this grant is made; that the said grantor(s), their heirs, successors and assigns, shall not

disturb, injure, molest or in any other manner interfer in any way whatsoever with any pipe, pipeline or material or any other matter or thing necessary or incidental to said storm sewer system, and that the said grantor(s) and each of them, their heirs, successors and assigns shall be governed by and shall comply with all of the covenants of this grant and also all of the rules, by-laws, ordinances and regulations that may hereinafter from time-to-time be made or adopted by said grantee, or its proper officers or representatives for the management, government, operation or control of any sewer system installed or operated by said Town, so far as the same may be applicable.
