

The letters from these groups are attached.

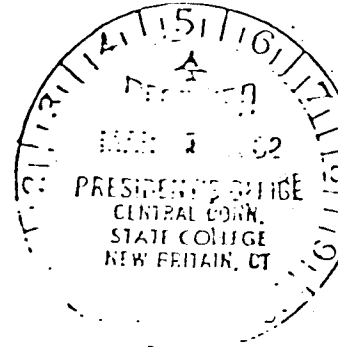
I am sure that both DEC groups would appreciate an acknowledgement and thank you from the Board of Trustees.

Dear Mr. James:

The Corporate Contributions Committee of Digital Equipment Corporation has reviewed your request for assistance with the acquisition of a VAX 11/780 computer system for Central Connecticut State College.

On behalf of the Committee, I am pleased to confirm to you that it was our decision to award Central Connecticut an equipment grant of 30%, not to exceed \$115,000 on the purchase of the 11/780.

Support of education is the highest priority of our Corporate Contributions program, and we are particularly pleased to be in a position to assist as fine a school as Central Connecticut with the expansion of your Computer Science programs.

As you may be aware, this grant is contingent upon your obtaining a Digital field service maintenance contract on the VAX to ensure that the system is properly maintained. Acceptance of the grant must take place before May 31, 1982.


Dear Mr. James:
