

- WHEREAS, The Trustees in Resolution Number 82-25 authorized Central Connecticut State College to request licensure for a concentration in General Business Management with the Master of Science in Organization and Management, and
- WHEREAS, The Board of Higher Education has suggested that Central explore the presentation of this program in cooperation with another institution or institutions which already have authorization for a Master's program in General Business, and
- WHEREAS, Central has developed a cooperative arrangement in which the Hartford Graduate Center will offer a limited number of courses in this program with most of the courses and the degree being offered by Central, therefore be it
- RESOLVED, That Resolution 82-25 is reconfirmed and that in addition Central is authorized to cooperate with the Hartford Graduate Center in presentation of courses in the General Business Management Concentration within the Master of Science in Organization and Management when this concentration receives the appropriate licensure.


