## RESOLUTION

concerning

**LECTURERS and STATE UNIVERSITY ASSISTANTS**

September 1, 1983

- WHEREAS,** The Board of Trustees had previously established the positions and salary schedules for lecturers and
- WHEREAS,** Employees previously employed as lecturers who perform teaching, counseling or library duties have chosen to participate in collective bargaining for purposes of determining wages, hours, and conditions of employment, now therefore be it
- RESOLVED,** That there continue to be the employment category of Lecturer I, Lecturer II, and Special Lecturers, and that the wages, hours and conditions of employment for these positions shall be determined by the collective bargaining process, and be it further
- RESOLVED,** That those individuals who are employed part-time and are not members of the permanent faculty or staff and whose employment does not include them in the bargaining unit as defined by the State Board of Labor Relations shall be employed in the following category at the salary indicated:
