DISPOSITION OF UNWANTED, DUPLICATE, OUT-OF-DATE OR IRRELEVANT LIBRARY MATERIALS

October 7, 1983

WHEREAS, Public Act No. 83-450, Section 3, authorizes the Board of Trustees for the Connecticut State University to provide for the disposition

of certain library materials, therefore be it

RESOLVED, That, except when specifically prohibited by the conditions, if any, upon which a gift was created or by a conditional sales agreement, the Board of Trustees of the Connecticut State University authorizes the Presidents of the Connecticut State University campuses to develop appropriate procedures, and in accordance therewith, to sell, trade, or otherwise dispose of any unwanted, duplicate, out-of-date or irrelevant materials within the campus libraries provided the money proceeds of such a transaction, if any, shall be deemed to be funds from private sources and, as such funds, shall be held in the manner prescribed by Section 4-31a of the General Statutes for use in furthering any purpose the President considers to be in harmony with the original purpose of the gift or purchase of such materials.

PUBLIC ACT NO. 83-450

AN ACT AUTHORIZING COLLEGE LIBRARIES TO DISPOSE OF SURPLUS LIBRARY MATERIAL.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

Section 1. (NEW) Except when specifically prohibited by the conditions, if any, upon which a qift was created or by a conditional sales agreement, the board of trustees for the regional community colleges is authorized to sell, trade, or otherwise dispose of any unwanted, duplicate, out-of-date or irrelevant materials within the libraries under the jurisdiction of the board. provided t he monetary proceeds of such a transaction, if any, shall be deemed to be funds from private sources and, as such funds, shall be held in the manner prescribed by section 4-31a of the general statutes for use in furthering any purpose the board considers to be in harmony with the original purpose of the gift or purchase of such materials.

(NEW) Except when specifically Sec. 2. prohibited by the conditions, if any, upon which a gift was created or by a conditional sales agreement, the board of trustees for the state technical colleges is authorized to sell, trade, or otherwise dispose of any unwanted, duplicate, out-of-date or irrelevant materials within the libraries under the jurisdiction of the board, provided the monetary proceeds of such a transaction, if any, shall be deemed to be funds from private sources and, as such funds, shall be held in the manner prescribed by section 4-31a of the general statutes for use in furthering any purpose the board considers to be in harmony with the original purpose of the gift or purchase of such materials.

Sec. (NEW) Except when specifically 3. prohibited by the conditions, if any, upon which a was created or by a conditional sales board of trustees agreement, the Connecticut State University is authorized to sell, trade, or otherwise dispose of any unwanted, duplicate, out-of-date or irrelevant materials within the libraries under the jurisdiction of the board, provided the monetary proceeds of such a transaction, if any, shall be deemed to be funds from private sources and, as such funds, shall be held in the manner prescribed by section 4-31a of the general statutes for use in furthering any

purpose the board considers to be in harmony with the original purpose of the gift or purchase of such materials.

(NEW) Except when specifically Sec. 4. prohibited by the conditions, if any, upon which a gift was created or by a conditional sales agreement, the board of trustees of The University of Connecticut is authorized to sell, trade, or otherwise dispose of any unwanted, duplicate, outof-date or irrelevant materials within the libraries under the jurisdiction of the board, provided the monetary proceeds of such a transaction, if any, shall be deemed to be funds from private sources and, as such funds, shall be held in the manner prescribed by section 4-31a of the general statutes for use in furthering any purpose the board considers to be in harmony with the original purpose of the gift or purchase of such materials.

Sec. 5. This act shall take effect July 1, 1983.
