concerning

A SEPARATE ORIENTATION FEE FOR NEW STUDENTS AT EASTERN CONNECTICUT STATE UNIVERSITY

January 6, 1984

- WHEREAS, Section 10a-99 of the General Statutes provides that the Board of Trustees for the Connecticut State University, subject to the approval of the Board of Governors for Higher Education, shall fix fees for such purposes as the Board of Trustees deems necessary, and
- WHEREAS, Eastern Connecticut State University administration has proposed and the Student Executive Board and the Student Senate have endorsed a change in the method of funding the orientation program for new students and their parents, be it
- RESOLVED, That, if the Board of Governors for Higher Education concurs, effective for the Fall 1984 semester, an Orientation Fee of fifteen dollars (\$15.00) shall be charged to all first-time students (freshmen and transfers) at Eastern Connecticut State University for the purpose of providing funds for the orientation program, and be it
- RESOLVED, That the amount of three dollars (\$3.00) per student previously allocated from the proceeds of the University General Fee for this purpose shall be redirected to other purposes appropriate to that fee, and be it

That the Orientation Fee shall not be refundable. RESOLVED.
