INCREASE IN STUDENT ACTIVITY FEE CENTRAL CONNECTICUT STATE UNIVERSITY

January 6, 1984

WHEREAS, Section 10a-99 of the General Statutes provides that the Board of Trustees for the Connecticut State University, subject to the approval of the Board of Governors for Higher Education, shall fix fees for such purposes as the Trustees deem necessary, and

WHEREAS, The Student Center Program Council of Central Connecticut State University has recommended an annual increase in the Student Activity Fee from \$43.56 to \$49.00 to meet the increase in Student Center program costs, be it

RESOLVED, That, if the Board of Governors for Higher Education concurs, the Student Activity Fee for Central Connecticut State University shall be increased from \$43.56 to \$49.00 per academic year, effective for the Fall Semester 1984.
