LEASE OUT PROPOSAL SUMMARY

ITEM: A lease-out of space for the installation of an automated teller machine.

LOCATION: Student Center Building, Western Connecticut State University, Danbury, Connecticut.

LESSOR: State of Connecticut.

LESSEE: Connecticut Bank and Trust Company, One Constitution Plaza, Hartford, Connecticut 06115.

SPACE: Approximately 60 square feet of space located in the basement lobby area.

TERM: Three (3) years.

EFFECTIVE DATE: Following all required approvals.

RATE: \$2,400.00 per year payable in monthly payments of \$200.00. In addition the LESSEE will pay the LESSOR 5% of the cash withdrawal transaction fee on all cash withdrawals over \$10,000.00 transactions per each month.

FACILITIES: The LESSOR shall provide and pay for: heat; electricity; and present building security.

The LESSOR shall also keep the automatic teller machine and the areas immediately surrounding the automatic teller machine clean and free of debris and shall not permit the adjacent area to be littered with refuse resulting from the use or operation of the automatic teller machine.

The LESSEE shall provide and pay for: the installation cost of an IBM 3624 Consumer Transaction Facility and its continued operation and maintenance; liability insurance with the State of Connecticut named as an additional insured.

The LESSEE will also provide and pay for any building plans with construction work related to the installation.

CLAUSE: The automatic teller machine shall remain the property of the LESSEE. The LESSOR shall not be liable for any damage to or loss of the automatic teller machine by reason of theft, vandalism, fire, water, power failure, accidents to or defects in plumbing, heating or by reason of any other cause whatsoever, other than the willful misconduct of its agents, conractors or employees.
