June 21, 1985

RESOLVED, That the service status of the position of Accountant II be reclassified from Classified-Exempt to Unclassified-Exempt; and that the title of this position be changed to Connecticut State University Assistant for Business Affairs to more correctly reflect the function and scope of this position; and be it

RESOLVED, That this new title, with additional duties as set forth in the proposal dated June 5, 1985, be assigned to the present incumbent of this position Gregg Blackstone, effective June 21, 1985, at the annual salary of \$29,000; and be it further

RESOLVED, That Mr. Blackstone be accorded all benefits as are currently available to all CSU "unclassified" management and confidential exempt personnel.

The duties and responsibilities discharged by the Accountant 2 incumbent of this position, Gregg Blackstone, are identical to those performed by campus personnel who carry administrator rank under the "unclassified" service of the CSU Board of Trustees. This requested reclassification will effect service consistency within this area of university fiscal and business affairs; and will result, also, in like treatment of all university personnel responsible for administering and/or managing the agency fiscal operation.

The proposed salary of \$29,000 reflects the July, 1985 anniversary increment and five and one-half (5.5%) percent across the board increase Mr. Blackstone would have received as Accountant 2 (which totals \$27,574); therefore, the actual cost of this reclassification is the difference between \$27,574 and \$29,000 -- or \$1,426.00.
