Position Title: Associate Vice President for Academic Affairs

Rank: Non-Faculty Position - Equivalent to Academic Dean

Department: Academic Affairs

Supervisor's Title: Vice President for Academic Affairs

POSITION SUMMARY:

This officer serves as chief of staff to the Vice President for Academic Affairs. As such, upon delegation by the Vice President, he supervises those functions within Academic Affairs designated by the Vice President.

RESPONSIBILITIES:

Acts as the Vice President's designee in:

- a. the administration and supervision of the Library, Media Center, Registrar's Office and Cooperative Education Program;
- b. the administration of academic resources;
- c. the review of program and curriculum development;
- d. the allocation and continuing accounting of the academic affairs budget.

Coordinates the freshman orientation program.

Prepares and oversees distribution of Curriculum Committee materials.

Performs other duties as assigned.

Earned doctorate and substantial teaching and administrative experience.
