RESOLVED,





RE: Authorization for Travel for Management and Confidential Unclassified Employees

On April 4, 1986, the Board of Trustees for the Connecticut State University, acting under the authority granted by Subsection (r) of Section 5-200 of the General Statutes, passed Board Resolution No. 86-52 (copy enclosed) which authorizes the President of the Connecticut State University to set standards and rates for travel reimbursement for Management and Confidential unclassified employees which shall be not less than those granted to employees of the Board of Trustees who are covered under a prevailing bargaining unit contract.

This is intended to enable the President of Connecticut State University to establish standards which will expedite the processing of documents necessary for travel authorization, expense reimbursement, etc., and, from time to time, to adjust rates to be commensurate with those negotiated for bargaining unit contracts.
