WHEREAS, A national search to fill the position of Assistant Vice President for Academic Affairs and Research has failed to result in a regular appointment to this position, and

WHEREAS, Professor Thomas B. Flaherty of the Department of Psychology of Central Connecticut State University has indicated a willingness to serve in this position on an acting basis, therefore, be it

RESOLVED, That Dr. Thomas B. Flaherty shall be placed on leave of absence without pay from his position as Professor of Psychology at Central Connecticut State University for the academic year 1986-87, and be it

RESOLVED, That Dr. Thomas B. Flaherty shall be appointed Acting Assistant Vice President for Academic Affairs and Research in the Executive Offices of the Connecticut State University for the period August 1, 1986 through June 30, 1987, at a salary of \$45,000 for that period of service, and be it

RESOLVED, That during his service as Acting Assistant Vice President for Academic Affairs and Research, Dr. Flaherty shall be entitled to all the benefits enumerated in the Board of Trustees' Personnel Policies for Management Personnel and Confidential Professional Personnel.
