- WHEREAS, Western Connecticut State University has conducted a search to fill the position, Dean of Graduate Studies and Extension Services (previously titled Dean, School of Graduate Studies and Continuing Education), and
- WHEREAS, The President of Western Connecticut State University, after due consultation with the faculty, has recommended the appointment of Dr. Norman E. Puffett, and
- WHEREAS, President Beal concurs in this recommendation, now therefore, be it
- RESOLVED, That effective December 15, 1986, under the terms and conditions of the Trustees' "Personnel Policies for Management and Confidential Professional Personnel," Dr. Norman E. Puffett be and hereby is appointed Dean of Graduate Studies and Extension Services at Western Connecticut State University, at a bi-weekly salary rate of \$2,107.28 (annual salary of \$55,000).

Developed course schedules, supervised faculty, and managed recruiting, financial aid, student services, custodial staff, registration, etc. Active in community affairs, participated in the development of various direct mail and advertising campaigns, prepared new releases, etc.
