

I have today received a phone call from Assistant Attorney General Tom Clifford saying that he has reviewed the proposed resolution accepting a gift to Central Connecticut State University of a "statue" or sculpture which was in turn given to the Foundation by ARA Services. We had questioned whether there would be any conflict of interest in accepting this gift since ARA is Central's food service vendor and will be bidding on contract renewals in the future. Mr. Clifford reviewed the status of the CCSU Foundation and found that it is totally separate from the University and therefore a gift to the Foundation does not constitute any kind of conflict problem. Mr. Clifford approved the language of the Resolution as submitted to him in draft form. A copy of this resolution is attached hereto.

RE: Gift from Vendor

I request informal advice on the appropriateness of the Trustees accepting a gift of sculpture from ARA Services via the Central development foundation, as proposed in the draft resolution, attached.

ARA Services is the vendor which currently has the food service contract at Central (and at Southern). Food service contracts are of course periodically put out for bid.

My concern is whether, by accepting this gift, we would be opening the Trustees and the administration at Central to charges of bias in the contract awarding process.

A copy of the Trustees policy on the acceptance of gifts is enclosed. This policy seeks to implement the authority granted to the Trustees in Section 10a-150 of the General Statutes.
